Pick 4 Friday's Bonus Bucks Online Promotion

Statewide Second Chance Promotion Rules & Regulations

GENERAL:

- 1. The Kentucky Lottery Corporation (KLC) plans to conduct the Pick 4 Friday's online promotion with the iLottery game Pick 4 pursuant to the provisions provided in these rules and regulations.
- 2. The promotional period will take place from 12:00:00 AM ET until 11:59:59 PM ET on the following Fridays in May 2024:
 - Friday, May 3, 2024
 - Friday, May 10, 2024
 - Friday, May 17, 2024
 - Friday, May 24, 2024
 - Friday, May 31, 2024
- 3. There will be one drawing for each promotional day for a total of Five (5) drawings. The drawings will be conducted on or about Thursday, June 6, 2024.
- 4. Players are eligible to receive one (1) entry each day of the promotion when the player has a qualifying play of Pick 4 online. A qualifying play is a successful purchase of the Pick 4 online game, regardless of price point.
- 5. Prizes will be awarded as follows:

Forty-four (44) winners will receive \$44 in Bonus Bucks per promotional period to play online. A total of \$9,680 in Bonus Bucks will be awarded.

- The Bonus Bucks will be deposited into the winners' Fun Club accounts within ten (10) business days following the promotional drawing.
- Bonus Bucks are applied directly to a player's Fun Club account and must be spent on games purchased via the KLC's website. Bonus Bucks cannot be withdrawn for a cash equivalent or redeemed for a retail purchase.
- 6. One (1) drawing will be conducted for each promotional day with a total of forty-four (44) winners for each promotional period and ten (10) alternates will be selected. A player may only win once during this promotional period.
- 7. Players are eligible to receive one (1) entry during the promotional period after completing a qualifying play from the following games: Pick 4. A qualifying play is a successful purchase, regardless of price point.
- 8. This promotion is only available at <u>play.kylottery.com</u>. Tickets purchased at retail are not eligible.
- 9. Player's funding transactions are subject to a player's Fun Club account balance and deposit limits.

- 10. All deposited funds must be spent on KLC games purchased via the Internet and cannot be withdrawn.
- 11. Qualifying plays must be completed during the designated times and days to be eligible for the drawings as identified in Item 4.
- 12. Failure to provide accurate information could disqualify a player whose entry is selected as a winner for this promotion. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements or provided false information.
- 13. The KLC assumes no responsibility for incorrect information provided by a player on the Fun Club registration form. After completing the registration, a player is responsible for updating account information as needed by logging in and going to his or her account profile page.
- 14. A player may have no more than one (1) account. A player is not permitted to create additional accounts if his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.

ELIGIBILITY:

- 15. To be eligible for the promotion, players must first register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
- 16. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the iLottery Terms of Use.
- 17. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this promotion or win any prize.

ODDS:

18. Odds of being selected as a winner in the promotion will depend on the number of eligible entries that take place during the promotional period.

SUBMITTING ENTRIES:

- 19. Players with a qualifying play during the promotional period will be automatically entered into the promotion.
- 20. Players will receive one (1) entry per promotional period as described in Item 7.
- 21. By playing qualifying game(s) during the promotional period, the players agree to these rules and regulations, the rules and regulations for the iLottery purchase of Instant Games, and the Fun Club and iLottery Terms of Use, and the Instant Play Game rules and regulations for the qualifying game(s).

PRIZE DRAWING:

- 22. At the conclusion of the promotional period, KLC will run an IGT system-generated report utilizing the criteria set forth for this promotion.
- 23. A member of the iLottery team will upload the system-generated report into the Promotional Drawing System.
- 24. All drawing management services associated with this promotion will be conducted by the KLC.
- 25. The drawings will be conducted per KLC drawing procedures.
- 26. During the drawings, alternates will be selected as noted in Item 6. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners, but are selected if a winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

PRIZE FULFILLMENT:

- 27. Bonus Bucks will appear in the designated winner player's Fun Club account within ten (10) business days following the promotional draw.
- 28. All federal, state and/or local taxes or other fees on the prizes won will be the responsibility of the winner.
- 29. The prize is not transferable or assignable.
- 30. Fulfillment of the prize will be handled by the KLC.

FULFILLMENT OF BONUS BUCKS:

31. In order to play internet-based games, the player must provide a valid U.S. address, be physically located within the boundaries of Kentucky at the time of purchase, and subject to age and identity verification. If the winner does not have a valid U.S. address, is not physically located within the boundaries of Kentucky at the time of purchase, or the winner's identity cannot be verified, the winner will not be able to purchase tickets online. The winner must notify the KLC once the account has been created and confirmed. Bonus Bucks are applied directly to a player's Fun Club account and must be spent on KLC games purchased via the Internet; Bonus Bucks cannot be withdrawn or redeemed for a retail purchase. Bonus Bucks will appear in the player's Fun Club account within 14 business days of creating the account.

ADDITIONAL CONDITIONS:

- 32. The promotion is subject to Kentucky law, the rules and regulations of the KLC, and the rules and regulations for Pick 4.
- 33. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are subject to rules and regulations of the KLC and the laws of the Commonwealth of Kentucky.

- 34. By entering this promotion and accepting the prize, the player acknowledges and agrees that the KLC may use and release the player's name, city/state, and likeness (photograph) to the public, without limitation and without compensation.
- 35. By entering this promotion and accepting the prize, each entrant, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the promotion, any action taken pursuant to these rules, or the acceptance of any prize.
- 36. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for particular purpose.
- 37. Age restrictions may apply to redeem vouchers for certain products, merchandise or services.
- 38. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this promotion including the drawing at any time and for any reason including the award of any prize with the approval of the President & CEO or appropriate designee from the Executive Management group.
- 39. The KLC reserves the right to substitute prizes of equivalent value.
- 40. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business Monday Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
- 41. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or appropriate designee from the KLC's Executive Management Group, will be final.
- 42. This promotion is void where prohibited by law.
