### LUCKY FOR LIFE™ OFFICIAL GAME RULES

## FOURTH AMENDED ADDENDUM

## Section 1 Governing Rules

All matters and claims relating to this "Lucky for Life" Game, including but not limited to purchases, transactions, determination of prize winners, validation, and prize claims, are governed by this Addendum, Kentucky law, the individual Lucky for Life Official Game Rules, and the Draw Game General Rules, which are incorporated herein by reference. The purchase of "Lucky for Life" through the Kentucky Lottery Corporation's website at kylottery.com ("iLottery") is governed by the Rules for the iLottery Purchase of Draw Games and the iLottery Terms of Use, which are incorporated, by reference, in addition to these Rules. These Rules collectively contain the sole and exclusive remedy for any and all claims.

## Section 2 Retailer Selling Bonus

The retailer selling bonus for the sale of a Top Prize-winning ticket shall be one percent (1%) of the twenty (20) year Top Prize minimum of \$7,300,000. The retailer selling bonus for the sale of a Prize Level 2 winning ticket shall be one percent (1%) of the twenty (20) year Prize Level 2 minimum of \$500,000. In the event there are multiple prize-winning tickets for a single prize, each retailer selling bonus will be reduced in proportion to the number of winners.

# Section 3 Proof of Life Requirement for Top and Prize Level 2 Winners

- (a) Once each year and no earlier than thirty (30) days prior to the anniversary of the validation date, each Top Prize and Prize Level 2 winner shall provide to the KLC an affidavit, on a form to be provided by the KLC, signed by the Winner, bearing the seal of a notary public, verifying that the Winner is living, containing the Winner's current address, and specifying the method of payment (check or wire transfer) and providing a bank account number and all information necessary to complete the wire transfer, if that option is chosen (the "Affidavit"). The Affidavit must be sent, by certified mail, to the KLC and must be received by the KLC during the thirty (30) day period prior to the anniversary of the validation date. In computing the period of time specified in these rules, the last day of the period so computed is to be included unless it is a Saturday, Sunday, or legal holiday, in which event the period runs until the end of the next day which is not a Saturday, Sunday, or legal holiday.
- (b) If a Winner does not provide the Affidavit specified in the preceding Section 2 (a), then the KLC may not make further prize payments until such time as it receives a completed Affidavit, or the notice and other information specified in Section 1 above. No interest shall be paid by the KLC on the value of the prize during any period that a prize payment was not made due to failure of the Winner to provide the Affidavit.
- (c) The KLC shall be notified of the Winner's death as soon as reasonably possible and such notice shall include a certified copy of the Winner's death certificate.

# Section 4 Interpretation of Lucky for Life Official Rules

The President of the Kentucky Lottery Corporation shall have the authority to interpret and apply, and if necessary, amend or modify the Lucky For Life Official Rules in order to comply with the laws of the Commonwealth of Kentucky and to implement sales of the Lucky For Life Game.

### Section 5 Internet Ticket Sales

All purchases on the website are governed by the KLC's Rules for the iLottery Purchase of Draw Games, the iLottery Terms of Use, and the Official Game Rules for Lucky for Life. A Lucky for Life iLottery Draw Game Ticket means an electronic or virtual ticket or play and is purchased only through the KLC's website. The purchase of a Lucky for Life iLottery Draw Game Ticket is a Game Purchase under the Official Game Rules for Lucky for Life, Part IV C.
