

**KENTUCKY LOTTERY CORPORATION**  
**Fun Club Registration and 100% Match of First-Ever Deposit Promotions**  
**Statewide Online Promotion**  
**Rules & Regulations**

**GENERAL:**

1. The Kentucky Lottery Corporation (KLC) plans to conduct a **Lotto Edge Promotion\*** for new Fun Club Members who are eligible to purchase KLC games via the Internet, pursuant to these Rules and Regulations.

**\*PROMO CODE: WELCOME**

2. The Promotion will run from **12:00 AM ET on Wednesday, April 1, 2026, through 11:59 PM ET on Thursday, April 30, 2026** (the “Promotional Period”). The KLC reserves the right to cancel or change the dates of the Promotion at any time and without notice.
3. The Promotion offers are as follows:
  - **Fun Club Registration Promotion:** Players who successfully register and join the Fun Club during the Promotional Period and enter the **Promo Code: WELCOME** on the registration page, will receive a \$5 Bonus. Players must pass age, identity, and location verification and have a valid US address to be eligible for the Promotion.
    - The Bonus should appear in the Player’s Fun Club account within twenty-four (24) hours of successful registration.
    - The Bonus will expire five (5) days after it appears in the Player’s Fun Club account.
    - The Bonus is only valid to purchase KLC Games via the Internet.
  - **100% First-Ever Deposit Match:** Players who make a first-ever deposit into their Fun Club account during the Promotional Period will receive a one hundred percent (100%) match in Bonuses, up to a maximum of \$250 in Bonuses. The 100% deposit match is only applicable to the first-ever Fun Club account deposit.
    - Players can fund their Fun Club account via credit/debit card, PayPal, bank account, or iFund at retail (the “funding transaction”). Winnings deposited into a Fun Club Account via mobile cashing are not a qualifying deposit for this Promotion.
    - The Bonus will appear in the Player’s Fun Club account after the Player has completed the funding transaction.
    - The Bonus will expire thirty (30) days after it appears in the Player’s Fun Club account.
    - The Bonus is only valid to purchase KLC Games via the Internet.
4. Bonuses have no cash value and cannot be withdrawn or redeemed for a retail purchase.

5. Deposited funds cannot be withdrawn or refunded and can only be used to Purchase KLC games online or at KLC retailers.
6. The Promotion offer is only available during the Promotional Period, subject to the KLC's rights set forth in Section 9 below.

**ADDITIONAL CONDITIONS:**

7. To be eligible for the Promotion, the Player must first successfully register for a Fun Club account at [kylottery.com](http://kylottery.com). The Player must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are suspended, Opted Out or Manually Disabled are ineligible to take part in this Promotion.
8. Player's funding transactions are subject to Fun Club account balance and deposit limits. If the addition of the funding amount would cause a Player's account balance or deposit limit to be exceeded, the funding amount cannot be added to the account.
9. The KLC, in its discretion, reserves the right to change or extend any of the dates set out in these rules. The KLC further reserves the right, in its sole discretion, to modify, suspend, postpone or cancel any portion of this Promotion or the entire Promotion, at any time and without notice, prior to the end of the Promotional Period, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
10. The KLC reserves the right to not award or revoke Bonuses and not award prizes to any player who the KLC suspects has engaged or attempted to engage in activity in violation of federal or Kentucky law, the Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, or any other applicable rules.
11. The Promotion is subject to Kentucky law, these rules, the rules and regulations of the KLC, Fun Club Rewards Terms of Use, and the iLottery Terms of Use.
12. To play Internet-based lottery games, Players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
13. This Promotion is void where prohibited by law.
14. This Promotion cannot be combined with any other deposit promotional offers.
15. This Promotion is only available at [www.kylottery.com](http://www.kylottery.com) and the official KLC mobile app.
16. By entering this Promotion and accepting a Bonus, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and

directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.

17. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or the designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
