## KENTUCKY LOTTERY CORPORATION Kentucky 5 iLottery My Rewards Online Promotion

**Rules & Regulations** 

## **GENERAL:**

- 1. The Kentucky Lottery Corporation (KLC) plans to conduct an iLottery online promotion with the Kentucky 5 online game pursuant to the provisions provided in these rules and regulations.
- 2. The promotional period will take place from 12:00:00 AM ET until 11:59:59 PM ET on the following Fridays in January:
  - January 12, 2024
  - January 19, 2024
  - January 26, 2024
- 3. The promotion offer is as follows:
  - Players who are eligible to play online and spend \$5 or more on Kentucky 5 online in a single transaction, will receive a \$1 Kentucky 5 My Rewards play.
  - The reward is limited to one (1) per account each Friday if players spend \$5 or more in Kentucky 5 and may only be used for online Kentucky 5 purchases.
  - All matters and claims relating to Kentucky 5 including tickets, transactions, drawings, prizes and prize claims, are governed by Kentucky law and the official rules and regulations for Kentucky 5. See <u>Kentucky 5 Rules</u> for details.
- 4. The \$1 Kentucky 5 My Rewards play will appear in the eligible player's Fun Club account, My Rewards tab, immediately after the qualifying purchase is complete.
- 5. The Kentucky 5 My Rewards play is applied directly to a player's Fun Club account and must be spent on a \$1 Kentucky 5 play purchased via the Internet; a My Rewards play cannot be withdrawn or redeemed for a retail purchase.
- 6. The My Rewards play will expire thirty (30) days after the promotional award appears in the player's account.
- 7. This promotion is only available at <u>play.kylottery.com</u>. Tickets purchased at retail are not eligible.
- 8. The promotion is only available during the Promotional Period.
- 9. Player's funding transactions are subject to a player's Fun Club account balance and deposit limits.
- 10. All deposited funds must be spent on KLC games purchased via the Internet and cannot be withdrawn.

## **ADDITIONAL CONDITIONS:**

- 11. The promotion is subject to Kentucky law, the rules and regulations of the KLC, and the rules and regulations for the Kentucky 5 game.
- 12. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the iLottery Terms of Use.
- 13. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this promotion or win any prize.
- 14. By entering this promotion and accepting the prize, each entrant, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the promotion, any action taken pursuant to these rules, or the acceptance of any prize.
- 15. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for particular purpose.
- 16. Age restrictions may apply to redeem vouchers for certain products, merchandise or services.
- 17. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this promotion including the drawing at any time and for any reason including the award of any prize with the approval of the President & CEO or appropriate designee from the Executive Management group.
- 18. The KLC reserves the right to substitute prizes of equivalent value.
- 19. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business Monday Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
- 20. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or appropriate designee from the KLC's Executive Management Group, will be final.
- 21. This promotion is void where prohibited by law.
