“MONOPOLY® 20X” SCRATCH OFF GAME NO. 111**

**1. GENERAL PROVISIONS**

“MONOPOLY® 20X” tickets are governed by these Game Rules and Regulations and the **General Rules Governing Instant (Scratch-off) Games (“Scratch-off General Rules”)**, which are incorporated herein by reference in their entirety. **The Scratch-off General Rules together with these Game Rules and Regulations govern all matters and claims relating to Scratch-off Games including tickets, transactions, drawings, prizes and prize claims. These Rules contain the sole and exclusive remedy for such claims.**

“MONOPOLY® 20X” tickets shall be made available for sale at the discretion of the President of the Kentucky Lottery Corporation. The price of each ticket shall be Two Dollars (\$2.00).

**2. GAME SUMMARY**

Each “MONOPOLY® 20X” ticket consists of scratch-off material covered play areas containing a total of twelve (12) Play Spots (ten (10) “YOUR SYMBOLS” Play Spots and two (2) “WINNING SYMBOLS” Play Spots) and ten (10) Prize Spots. The player determines if the ticket is a winner by removing the scratch-off material from the Play Areas. If the player matches any of the “YOUR SYMBOLS” Play Symbols to any of the “WINNING SYMBOLS” Play Symbols, the player shall win the prize amount shown directly below that Symbol. If the player reveals a “10X” Play Symbol in the “YOUR SYMBOLS” Play Area, the player shall win ten (10) times the prize amount shown directly below that Symbol. If the player reveals a “20X” Play Symbol in the “YOUR SYMBOLS” Play Area, the player shall win twenty (20) times the prize amount shown directly below that Symbol. If the player reveals a “DOG” Play Symbol in the “YOUR SYMBOLS” Play Area, the player shall win all ten (10) prizes. A player may win up to ten (10) times and up to Twenty-Five Thousand Dollars (\$25,000.00) on each “MONOPOLY® 20X” ticket.

The game consists of approximately 2,040,000 tickets ordered. The approximate number of winners and the value of the prizes, along with the approximate odds of winning based on 2,040,000 tickets ordered, are listed below.

The determination of prize winners is subject to validation pursuant to the following Prize Structure and as set forth in the Scratch-off General Rules, respectively.

- a. **“YOUR SYMBOLS” Play Symbols:** There are ten (10) “YOUR SYMBOLS” Play Spots. The symbols will appear in black in positive with Captions in black in positive as shown below.



- b. **“WINNING SYMBOLS” Play Symbols:** There are two (2) “WINNING SYMBOLS” Play Spots. The Symbols will appear in black with Captions in black in positive as shown below.



- c. **Prize Symbols:** There are ten (10) Prize Spots. The Symbols will appear in black in positive with Captions in black in positive as shown below.

#### 4. **DETERMINATION OF “MONOPOLY® 20X” PRIZE WINNERS**

The determination of prize winners is subject to “Ticket Validation Requirements” and “Claim Period” set forth in the Scratch-off General Rules, and as set forth below:

Each “**MONOPOLY® 20X**” ticket consists of scratch-off material covered play areas containing a total of twelve (12) Play Spots (ten (10) “YOUR SYMBOLS” Play Spots and two (2) “WINNING SYMBOLS” Play Spots) and ten (10) Prize Spots. The player determines if the ticket is a winner by removing the scratch-off material from the Play Areas. If the player matches any of the “YOUR SYMBOLS” Play Symbols to any of the “WINNING SYMBOLS” Play Symbols, the player shall win the prize amount shown directly below that Symbol. If the player reveals a “10X” Play Symbol in the “YOUR SYMBOLS” Play Area, the player shall win ten (10) times the prize amount shown directly below that Symbol. If the player reveals a “20X” Play Symbol in the “YOUR SYMBOLS” Play Area, the player shall win twenty (20) times the prize amount shown directly below that Symbol. If the player reveals a “DOG” Play Symbol in the “YOUR SYMBOLS” Play Area, the player shall win all ten (10) prizes. A player may win up to ten (10) times and up to Twenty-Five Thousand Dollars (\$25,000.00) on each “**MONOPOLY® 20X**” ticket. The prizes that may be awarded are as follows:
