RULES AND REGULATIONS
“DID I WIN?” SCRATCH OFF GAME NO. 130**

1. GENERAL PROVISIONS

“DID I WIN?” tickets are governed by these Game Rules and Regulations and the **General Rules Governing Instant (Scratch-off) Games (“Scratch-off General Rules”)**, which are incorporated herein by reference in their entirety. **The Scratch-off General Rules together with these Game Rules and Regulations govern all matters and claims relating to Scratch-off Games including tickets, transactions, drawings, prizes and prize claims. These Rules contain the sole and exclusive remedy for such claims.**

“DID I WIN?” tickets shall be made available for sale at the discretion of the President of the Kentucky Lottery Corporation. The price of each ticket shall be Five Dollars (\$5.00).

2. GAME SUMMARY

Each “DID I WIN?” ticket consists of a scratch-off material covered play area containing a total of fifteen (15) Play Spots and fifteen (15) Prize Spots. The player determines if the ticket is a winner by removing the scratch-off material from the play area. If the player reveals a “YES” Play Symbol in the play area, the player shall win the prize amount shown directly below that Play Symbol. If the player reveals a “NICE” Play Symbol in the play area, the player shall win two times (2X) the prize amount shown directly below that Play Symbol. If the player reveals a “YAHOO” Play Symbol in the play area, the player shall win three times (3X) the prize amount shown directly below that Play Symbol. If the player reveals a ”MONEYROLL” Play Symbol in the play area, the player shall win Fifty Dollars (\$50) instantly. A player may win up to fifteen (15) times and up to Fifty Thousand Dollars (\$50,000.00) on each “DID I WIN?” ticket.

The game consists of approximately 4,080,000 tickets ordered. The approximate number of winners and the value of the prizes, along with the approximate odds of winning based on 4,080,000 tickets ordered, are listed below.

The determination of prize winners is subject to validation pursuant to the following Prize Structure and as set forth in the Scratch-off General Rules, respectively.

3. **GAME SYMBOLS** – The Game Symbols for “DID I WIN?” are set forth below. The exact Game Symbols as set forth in these Game Rules and Regulations must appear beneath the rub-off area of the ticket.

a. **Prize Symbols:** There are fifteen (15) Prize Spots. The symbols will appear in black in positive with Captions in black in positive as shown below.

b. **Play Symbols:** There are fifteen (15) Play Spots. The Symbols will appear in black in positive with Captions in black in positive as shown below.

4. **DETERMINATION OF “DID I WIN?” PRIZE WINNERS**

The determination of prize winners is subject to “Ticket Validation Requirements” and “Claim Period” set forth in the Scratch-off General Rules, and as set forth below:

Each “**DID I WIN?**” ticket consists of a scratch-off material covered play area containing a total of fifteen (15) Play Spots and fifteen (15) Prize Spots. The player determines if the ticket is a winner by removing the scratch-off material from the play area. If the player reveals a “YES” Play Symbol in the play area, the player shall win the prize amount shown directly below that Play Symbol. If the player reveals a “NICE” Play Symbol in the play area, the player shall win two times (2X) the prize amount shown directly below that Play Symbol. If the player reveals a “YAHOO” Play Symbol in the play area, the player shall win three times (3X) the prize amount shown directly below that Play Symbol. If the player reveals a ”MONEYROLL” Play Symbol in the play area, the player shall win Fifty Dollars (\$50) instantly. A player may win up to fifteen (15) times and up to Fifty Thousand Dollars (\$50,000.00) on each “DID I WIN?” ticket.

The prizes that may be awarded are as follows:

\$15	=	(Fifteen Dollars) or
\$50	=	(Fifty Dollars) or
\$100	=	(One Hundred Dollars) or
\$200	=	(Two Hundred Dollars) or

\$1,000	=	(One Thousand Dollars) or
\$50,000	=	(Fifty Thousand Dollars).

5.REORDER

If determined by the KLC’s President or her designee, and as set forth in the General Rules, this game (KY-130) is subject to a full reorder of tickets. The reorder may consist of the prize structure set out below.
