RULES AND REGULATIONS
“SUPER 7’S” SCRATCH OFF GAME NO. 140**

1. GENERAL PROVISIONS

“SUPER 7’S” tickets are governed by these Game Rules and Regulations and the **General Rules Governing Instant (Scratch-off) Games (“Scratch-off General Rules”)**, which are incorporated herein by reference in their entirety. **The Scratch-off General Rules together with these Game Rules and Regulations govern all matters and claims relating to Scratch-off Games including tickets, transactions, drawings, prizes and prize claims. These Rules contain the sole and exclusive remedy for such claims.**

“SUPER 7’S” tickets shall be made available for sale at the discretion of the President of the Kentucky Lottery Corporation. The price of each ticket shall be Three Dollars (\$3.00).

2. GAME SUMMARY

Each “SUPER 7’S” ticket consists of scratch-off material covered play areas containing a total of nine (9) GAMES consisting of sixty-three (63) Play Spots (eighteen (18) “YOUR NUMBERS” Play Spots and thirty-six (36) “GAME NUMBERS” Play Spots (four (4) per GAME)) and nine (9) Prize Spots. The player determines if the ticket is a winner by removing the scratch-off material from the play areas. The player will scratch the “YOUR NUMBERS” Play Area to reveal eighteen (18) “YOUR NUMBERS” Play Symbols. For each “YOUR NUMBERS” Play Symbol revealed, the player will scratch the matching “GAME NUMBERS” symbol each time it appears in “GAMES 1-9.” If a player matches all four (4) “GAME NUMBERS” Play Symbols in a GAME, the player shall win the prize amount shown directly below that GAME. Each game is played separately. A player may win up to nine (9) times and up to Fifty Thousand Dollars (\$50,000.00) on each “SUPER 7’S” ticket.

The game consists of approximately 1,920,000 tickets ordered. The approximate number of winners and the value of the prizes, along with the approximate odds of winning based on 1,920,000 tickets ordered, are listed below.

The determination of prize winners is subject to validation pursuant to the following Prize Structure and as set forth in the Scratch-off General Rules, respectively.

4. DETERMINATION OF “SUPER 7’S” PRIZE WINNERS

The determination of prize winners is subject to “Ticket Validation Requirements” and “Claim Period” set forth in the Scratch-off General Rules, and as set forth below:

Each “SUPER 7’S” ticket consists of scratch-off material covered play areas containing a total of nine (9) GAMES consisting of sixty-three (63) Play Spots (eighteen (18) “YOUR NUMBERS” Play Spots and thirty-six (36) “GAME NUMBERS” Play Spots (four (4) per GAME)) and nine (9) Prize Spots. The player determines if the ticket is a winner by removing the scratch-off material from the play areas. The player will scratch the “YOUR NUMBERS” Play Area to reveal eighteen (18) “YOUR NUMBERS” Play Symbols. For each “YOUR NUMBERS” Play Symbol revealed, the player will scratch the matching “GAME NUMBERS” symbol each time it appears in “GAMES 1-9.” If a player matches all four (4) “GAME NUMBERS” Play Symbols in a GAME, the player shall win the prize amount shown directly below that GAME.
