RULES AND REGULATIONS
“WILD 8’s®” – SCRATCH OFF GAME NO. 696**

1. GENERAL PROVISIONS

“WILD 8’s®” tickets are governed by these Game Rules and Regulations and the **General Rules Governing Instant (Scratch-off) Games (“Scratch-off General Rules”)**, which are incorporated herein by reference in their entirety. **The Scratch-off General Rules together with these Game Rules and Regulations govern all matter and claims relating to Scratch-off Games including tickets, transactions, drawings, prizes and prize claims. These Rules contain the sole and exclusive remedy for such claims.**

“WILD 8’s®” tickets shall be made available for sale at the discretion of the President of the Kentucky Lottery Corporation. The price of each ticket shall be One Dollar (\$1.00).

2. GAME SUMMARY

Each “WILD 8’s®” ticket displays one (1) of five (5) pulses and for each pulse, one (1) of five (5) scenes and consists of a latex covered play area containing a total of ten (10) Play Spots (nine (9) Play Spots and one (1) “Bonus Box” Play Spot) and one (1) Prize Spot. The player determines if the ticket is a winner by removing the scratch-off material from the play area. If the player finds three (3) “8” symbols in the same row, column or diagonal line in the play area, the player shall win the prize shown in the Prize Box. If the player finds a “2X”, “3X” or “4X” symbol in the “Bonus Box” play area, the player shall win two (2) times, three (3) times or four (4) times the prize won, respectively. A player may win up to one (1) time and up to Eight Thousand Dollars (\$8,000.00) on each “WILD 8’s®” ticket.

The game consists of approximately 9,120,000 tickets ordered. The approximate the prize shown for that row. number of winners and the value of the prizes, along with the approximate odds of winning based on 9,120,000 tickets ordered, are listed below.

The determination of prize winners is subject to validation pursuant to the following Prize Structure and as set forth in the Scratch-off General Rules, respectively.

4. **DETERMINATION OF “Wild 8’s®” PRIZE WINNERS**
