1. GENERAL PROVISIONS

If the player matches any of the "Your Numbers" Play Symbols to any of the "Winning Numbers" Play Symbols, the player shall win the corresponding prize shown directly below that matching "Your Numbers" Play Symbol. If the player reveals a "\$50 Burst" symbol in the "Your Numbers" play area, the player shall win Fifty Dollars (\$50) instantly. If the player reveals a "\$100 Burst" symbol in the "Your Numbers" play area, the player shall win One Hundred Dollars (\$100) instantly. If the player reveals a "\$500 Burst" symbol in the "Your Numbers" play area, the player shall win Five Hundred Dollars (\$500) instantly.
