KENTUCKY LOTTERY CORPORATION OFFICE OF THE PRESIDENT RULES AND REGULATIONS "FLAMINGO BINGO" SCRATCH OFF GAME NO. 985

1. GENERAL PROVISIONS

"FLAMINGO BINGO" tickets are governed by these Game Rules and Regulations and the General Rules Governing Instant (Scratch-off) Games ("Scratch-off General Rules"), which are incorporated herein by reference in their entirety. The Scratch-off General Rules together with these Game Rules and Regulations govern all matters and claims relating to Scratch-off Games including tickets, transactions, drawings, prizes and prize claims. These Rules contain the sole and exclusive remedy for such claims.

"FLAMINGO BINGO" tickets shall be made available for sale at the discretion of the President of the Kentucky Lottery Corporation. The price of each ticket shall be Five Dollars (\$5.00).

2. GAME SUMMARY

Each "FLAMINGO BINGO" ticket consists of scratch-off material covered play areas containing a total of one hundred twenty-seven (127) Play Spots (one hundred (100) "Bingo Cards 1-4" Play Spots and twenty-seven (27) "Caller's Card" Play Spots). The player determines if the ticket is a winner by removing the scratch-off material from the play area. The player scratches the "Caller's Card" play area to reveal twenty-seven (27) "Caller's Card" numbers. The player then rubs the corresponding numbers on Cards 1 through 4, as well as the four (4) Free Play Spots on each card. If in any one of the Cards 1 through 4 the player matches all five (5) numbers in a complete horizontal, vertical, or diagonal line; matches all numbers in all four (4) corners; or matches to make a complete "X" (eight (8) numbers plus the free spot), the player wins the corresponding prize in the prize box printed directly below that Card. If the player reveals one (1) or more "Flamingo" symbol(s) under a number on any "Bingo Card 1-4" that matches a "Caller's Card" number, the player shall win the corresponding prize in the Flamingo Bonus Legend based on the number of "Flamingo" symbols under the matched Bingo numbers. Excluding Bonus Flamingo wins, a player can only win one (1) prize on each Card, but prizes can be won on up to four (4) Cards, provided that each Card has a winning pattern. Only the Bingo numbers matching the Caller's Card numbers can be used to reveal a "Flamingo" symbol on a Card. A winning ticket can only win the highest prize shown in the Flamingo Bonus Legend for that same number of "Flamingo" symbols revealed in all four (4) Cards. A player may win up to five (5) times and up to Eighty Thousand Dollars (\$80,000) on each "FLAMINGO BINGO" ticket.

The game consists of approximately 1,080,000 tickets ordered. The approximate number of winners and the value of the prizes, along with the approximate odds of winning based on 1,080,000 tickets ordered, are listed below.

The determination of prize winners is subject to validation pursuant to the following Prize Structure and as set forth in the Scratch-off General Rules, respectively.





4. <u>DETERMINATION OF "FLAMINGO BINGO" PRIZE WINNERS</u>

The determination of prize winners is subject to "Ticket Validation Requirements" and "Claim Period" set forth in the Scratch-off General Rules, and as set forth below:

Each "FLAMINGO BINGO" ticket consists of scratch-off material covered play areas containing a total of one hundred twenty-seven (127) Play Spots (one hundred (100) "Bingo Cards 1-4" Play Spots and twenty-seven (27) "Caller's Card" Play Spots). A winning ticket can only win the highest prize shown in the Flamingo Bonus Legend for that same number of "Flamingo" symbols revealed in all four (4) Cards. A player may win up to five (5) times and

up to Eighty Thousand Dollars (\$80,000) on each "FLAMINGO BINGO" ticket. The prizes that may be awarded are as follows:
