**FAST PLAY
\$10 HOLIDAY LUCK**

1. CREATION

Pursuant to the laws creating and governing the Kentucky Lottery Corporation, there is hereby created an instant terminal game, Fast Play, hereinafter called “\$10 HOLIDAY LUCK” which shall be conducted pursuant to these Rules and Regulations and KRS Chapter 154A and shall continue until the President publicly announces a termination date. FAST PLAY \$10 HOLIDAY LUCK is one game in a series of Fast Play games which all contribute to a Rolling Jackpot.

Sales of FAST PLAY \$10 HOLIDAY LUCK are effective at the start of business on or about November 14, 2024, at approximately 5:00 a.m. ET, or as announced by the Lottery. Fast Play games, including \$10 HOLIDAY LUCK are not available for purchase through iLottery.

2. GENERAL PROVISIONS

“\$10 HOLIDAY LUCK” tickets are governed by these Game Rules and Regulations and the General Rules Governing Terminal-Generated Fast Play Games (“Fast Play General Rules”), which are incorporated herein by reference in their entirety. **The Fast Play General Rules together with these Game Rules and Regulations govern all matters and claims relating to Fast Play Games including tickets, transactions, drawings, prizes and prize claims. These Rules contain the sole and exclusive remedy for such claims.**

3. DEFINITIONS

The following words and terms shall have the following meaning unless otherwise indicated:

- (a) **HOLIDAY NUMBERS** - Four (4) computer-selected HOLIDAY NUMBER Symbols from the HOLIDAY NUMBERS Symbol Bank, with one (1) HOLIDAY NUMBER in each GAME.
- (b) **YOUR NUMBERS**- Twenty-four (24) computer-selected YOUR NUMBERS Symbols from the YOUR NUMBERS Symbol Bank with six (6) YOUR NUMBERS in each GAME.

- (c) **HOLIDAY NUMBERS & YOUR NUMBERS SYMBOL BANK** - Numbers from a field of (1) through (60).
- (d) **MULTIPLIER SYMBOLS – Multiplier symbols from the MULTIPLIER SYMBOLS BANK with one (1) MULTIPLIER SYMBOL in each GAME.**
- (e)
- (f) **GAME-** One (1) computer-selected HOLIDAY NUMBER, six (6) computer-selected YOUR NUMBERS each with a corresponding PRIZE SYMBOL from the PRIZE SYMBOLS Bank, and one (1) computer-selected MULTIPLIER Symbol. Each Ticket contains four (4) GAMES.
- (g) **WINNING NUMBERS AND MONEY BAG NUMBERS SYMBOL BANK –** Numbers from a field of (1) through sixty (60).

- (h) **MULTIPLIER SYMBOLS BANK -**

1X 2X 5X 10X 20X

- (i) **PRIZE SYMBOLS BANK** - The twelve (12) Symbols representing the cash amounts of: TEN DOLLARS (\$10); FIFTEEN DOLLARS (\$15); TWENTY DOLLARS (\$20); TWENTY FIVE DOLLARS (\$25); FIFTY DOLLARS (\$50); ONE HUNDRED DOLLARS (\$100); ONE HUNDRED FIFTY DOLLARS (\$150); TWO HUNDRED DOLLARS (\$200); TWO HUNDRED FIFTY DOLLARS (\$250); FIVE HUNDRED DOLLARS (\$500); ONE THOUSAND DOLLARS (\$1,000); FIVE THOUSAND DOLLARS (\$5,000); and the JACKPOT which are displayed on each Ticket underneath each YOUR NUMBERS symbol.

- (j) **ROLLING JACKPOT** - A percentage of sales from each Fast Play Ticket sold will be rolled into the single Fast Play Rolling Jackpot fund which includes sales from all participating Fast Play games. The percentage of the Rolling Jackpot paid to the winner (10%, 20%, 30%, 50%, or 100%) will depend on the price point of the Fast Play Ticket purchased.
- (k) **ESTIMATED JACKPOT** - At the time of purchase, the “Current Estimated Fast Play Jackpot” amount will print at the top of every \$10 HOLIDAY LUCK Ticket. If a “Jackpot” win is triggered by a FAST PLAY \$10 HOLIDAY LUCK purchase, the Player will receive one hundred percent (100%) of the Current Estimated Jackpot fund printed on the Ticket rounded down to the nearest whole dollar (the difference is the “breakage”). The breakage shall remain in the Jackpot fund. The Rolling Jackpot amount will be reduced by the one hundred percent (100%) won by the Player, to ten thousand dollars (\$10,000) and then will continue to increase with each purchase of a Fast Play Ticket.

3. PURPOSE AND GENERAL DESCRIPTION

Each \$10 HOLIDAY LUCK ticket contains four (4) GAMES. Each GAME consists of One (1) computer-selected HOLIDAY NUMBER, six (6) computer-selected YOUR NUMBERS displayed in a vertical column below the HOLIDAY NUMBER with a corresponding PRIZE SYMBOL beneath each YOUR NUMBER, and one (1) computer-selected MULTIPLIER Symbol displayed below YOUR NUMBERS. A total of twenty-four (24) YOUR NUMBERS, four (4) HOLIDAY NUMBERS, and four (4) Multiplier Symbols will appear on each ticket. Each Game is played separately.

The purpose of \$10 HOLIDAY LUCK shall be to, within a single GAME, match any YOUR NUMBERS to the HOLIDAY NUMBER, win the corresponding PRIZE shown below that matching YOUR Number. If a PRIZE is won within a GAME and the GAME contains a 2X MULTIPLIER, multiply your winning in that GAME by two (2) times. If a PRIZE is won within a GAME and the GAME contains a 5X MULTIPLIER, multiply your winnings in that GAME by five (5) times. If a prize is won within a GAME and the GAME contains a 10X MULTIPLIER, multiply your winnings in that GAME by ten (10) times. If a PRIZE is won within a GAME and the GAME contains a 20X MULTIPLIER, multiply your winnings in that GAME by twenty (20) times. Each GAME is played separately. A player can win up to four (4) times and up to five thousand dollars (\$5,000) on a Ticket, excluding the Jackpot. If a Player wins the “Jackpot” by matching a HOLIDAY NUMBER to a YOUR NUMBERS with a corresponding “Jackpot” symbol within a GAME, no other prizes will be won on the Ticket other than the single Jackpot prize.

If a Player gets a “Jackpot”, the Player shall win 100% of the Current Estimated Jackpot amount printed on the Ticket. The Rolling Jackpot amount will be reduced by the one hundred percent (100%) won by the Player, reset to \$10,000, and shall grow as subsequent Tickets are sold, until the Rolling Jackpot is won.

All prizes won on a FAST PLAY \$10 HOLIDAY LUCK Ticket must be claimed within 180 days of purchase.

4. TICKET PRICE

The cost of FAST PLAY \$10 HOLIDAY LUCK is ten dollars (\$10) per Ticket.

5. DETERMINATION OF PRIZE WINNERS AND PROBABILITY OF WINNING

- (a) The overall odds of winning FAST PLAY \$10 HOLIDAY LUCK are as follows:

- (b) The FAST PLAY \$10 HOLIDAY LUCK prizes will be replenished in the prize structure automatically when each prize is won. If the Rolling Jackpot is won on any Fast Play game, the Estimated Jackpot shall be reduced by the percentage of the jackpot won (which depends on the price point of the Fast Play game). If the Estimated Jackpot falls below \$10,000, the Estimated Jackpot shall reset to


\$10,000. Odds remain the same for each Player for each tier and all prize tiers are available for every Player.

(c) The number of Prize Categories and the allocation of prize money among the Prize Categories may be changed at the discretion of the President and Board of Directors. Such change shall be announced by public notice.



All other matters and claims relating to this Fast Play Game, \$10 HOLIDAY LUCK, including but not limited to purchases, transactions, determination of prize winners, validation, and prize claims, are governed by Kentucky law and the official Fast Play General Rules, incorporated herein by reference. The Rules contain the sole and exclusive remedy for any and all claims.




