

Holiday 2022 iFunds/iGifts 50% Deposit Match

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a promotion for Fun Club Members who are eligible to purchase KLC games via the Internet.
2. The Promotion will run from 12:00 AM ET Monday, Nov 21, 2022 - 11:59 PM ET Friday, December 16, 2022 (the "Promotional Period"), unless otherwise notified. The KLC reserves the right to change the dates of the Promotion.
3. The Promotion offer is as follows:
 - Players who purchase an iFund or iGift at retail during the Promotional Period will have their deposit matched by fifty percent (50%), up to maximum total cumulative amount of \$200. A player can receive a maximum match award of \$100 in Bonus Bucks. For example:
 - i. If a player deposited \$50 from an initial deposit during the promotional period, the player would receive a match of \$25 in Bonus Bucks. If the next deposit was another \$50, making a total cumulative deposit of \$100, the player would receive another match of \$25 in Bonus Bucks. Once the player has reached a cumulative deposit amount of \$200 during the promotional period, they are no longer eligible to receive a match on subsequent deposits.
 - The promotion only applies to iFund/iGift at retail (the "funding transaction"). Deposits made through credit/debit card, PayPal, or bank account are not eligible.
4. You must be 18 years of age or older to purchase an iFunds or iGift.
5. This promotion is only available via a purchase at a retail location.
6. For iFunds, Bonus Bucks will appear in the player's Fun Club account after the player has completed the funding transaction during the promotional period. For iGifts, the Bonus Bucks will appear in the player's account once the player has entered the code onto the appropriate page on the website, as long as the entry is during the promotional period.
 - If the player waits to redeem the iGift until after the promotional period, the player will not receive the 50% match.
7. Bonus Bucks are applied directly to a player's Fun Club account and must be spent on KLC games purchased via the Internet; Bonus Bucks cannot be withdrawn or redeemed for a retail purchase.
8. All deposited funds must be spent on KLC games purchased via the Internet and cannot be withdrawn.
9. The Promotion offer is only available during the Promotional Period.

ADDITIONAL CONDITIONS:

10. Player's funding transactions are subject to a player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
11. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
12. The Promotion is subject to Kentucky law and rules and regulations of the KLC.
13. To play Internet-based lottery games, players must be at least 18 years old, have a valid KY address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club and iLottery Terms of Use.
14. This Promotion is void where prohibited by law.
15. This deposit promotion cannot be combined with any other deposit promotional offers.
16. This Promotion is only available at www.kylottery.com.
17. By funding their Fun Club account, players agree to these rules and regulations, the Terms of Use for Fun Club and the iLottery Terms of Use and the Privacy Policy.
18. By entering this promotion and accepting the prize, bonus, or award, each entrant/participant, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.
19. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or the designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
