

**KENTUCKY LOTTERY CORPORATION**  
**KY Lottery Summer Fortune Skies Online Promotion**  
Statewide Instant Play Second Chance Promotion  
Rules & Regulations

**GENERAL:**

1. The Kentucky Lottery Corporation (KLC) plans to conduct an Instant Play online promotion with Fortune Skies under the provisions provided in these rules and regulations.
2. The promotional period will take place from 12:00:00 AM ET on Monday, July 12, 2021 until 11:59:59 PM ET on Friday, July 23, 2021. The drawing will be held on or about Tuesday, July 27, 2021.
3. Prize will be awarded as follows:  
Twenty (20) winners will receive KY Lottery Summer Bag filled with KY Lottery-themed items which has an approximate total value of \$50 and includes:
  - a KY Lottery Zip Tote Bag
  - a KY Lottery Beach Towel
  - a Kentucky Lottery Umbrella
  - a Kentucky Lottery Hat
  - a Kentucky Lottery Tumbler
  - 2 Kentucky Lottery t-shirts – one large blue and one XL grey
  - 2 Kentucky Lottery Magnetic clips great for beach towel clips
4. One drawing will be conducted and twenty (20) winners with ten (10) alternates will be selected.
5. Players are eligible to receive one (1) entry for each qualifying Fortune Skies play during the promotional period. Any play regardless of price point qualifies for one entry in this promotion. A “TRY” is not a qualifying play.
6. This promotion is only available at [play.kylottery.com](http://play.kylottery.com). Tickets purchased at retail are not eligible.
7. Player’s funding transactions are subject to a player’s Fun Club account balance and deposit limits.
8. All deposited funds must be spent on KLC games purchased via the Internet and cannot be withdrawn.
9. Qualifying plays must be completed by 11:59:59 PM ET on Friday, July 23, 2021 to be eligible for the drawing on or about Tuesday, July 27, 2021.
10. Failure to provide accurate information could disqualify a player whose entry is selected as a winner for this promotion. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements or provided false information.

11. The KLC assumes no responsibility for incorrect information provided by a player on the Fun Club registration form. After completing the registration, a player is responsible for updating account information as needed by logging in and going to his or her account profile page.
12. A player may have no more than one (1) account. A player is not permitted to create additional accounts if his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.

**ELIGIBILITY:**

13. To be eligible for the promotion, players must first register for a Fun Club account at [kylottery.com](http://kylottery.com). Players must be in compliance with all requirements of the Fun Club Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
14. To play internet-based lottery games, players must be at least 18 years old, have a valid KY address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the iLottery Terms of Use.
15. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this promotion or win any prize.

**ODDS:**

16. Odds of being selected as a winner in the promotion will depend on the number of eligible entries that take place during the promotional period.

**SUBMITTING ENTRIES:**

17. Players with a qualifying play during the promotional period will be automatically entered into the promotion.
18. Players will receive one (1) entry for each qualifying play as described in Item 5.
19. By playing qualifying game(s) during the promotional period, the players agree to these rules and regulations, the rules and regulations for the iLottery purchase of Instant Games, and the Fun Club and iLottery Terms of Use, and the Instant Play Game rules and regulations for the qualify game(s).
20. A player is allowed to win only one prize in this promotion.

**PRIZE DRAWING:**

21. At the conclusion of the promotional period, KLC will run an IGT system-generated report utilizing the criteria set forth for this promotion.
22. A member of the iLottery team will upload the system-generated report into the Promotional Drawing System.

23. All drawing management services associated with this promotion will be conducted by the KLC.
24. The drawing will be conducted per KLC drawing procedures.
25. During the drawing, alternates will be selected as noted in Item 4. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners, but are selected if a winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

**PRIZE FULFILLMENT:**

26. A member of the KLC's iLottery Department will attempt to contact the winners using the phone and email contact information provided in the winner's Fun Club profile at the time of the drawings. The KLC may take the following steps to contact the winner:
  - Call both the primary and, if provided, the secondary phone number provided on the profile until winner has been reached by phone or has been disqualified (continued attempts to contact by phone will not be made to numbers that have been disconnected or are no longer in use by winner);
  - If the KLC does not reach the winner by phone, the KLC will immediately send the winner an email.
27. If the KLC determines that dialogue with the winner has not been established by phone, email, or other means acceptable to the KLC, within two (2) business days following the date of the KLC's initial attempted contact, the winner will be disqualified and the prize will be awarded to the first eligible alternate selected. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted, the prize(s) will not be awarded. If, prior to the expiration of the two (2) business days, the winner declines to accept and claim the prize by notifying a member of the iLottery Team in writing via the winner's e-mail, the prize may be forfeited immediately upon receipt of the written notification and the first eligible alternate declared the winner. Unless advised otherwise by the player, the KLC will mail the prize to the address on record with the player's Fun Club account. If the prize is returned as undeliverable, the KLC will make one (1) additional attempt to contact the winner and make delivery of the prize. If this attempt is unsuccessful, the prize will be forfeited and not awarded.
28. All federal, state and/or local taxes or other fees on the prizes won will be the responsibility of the winner.
29. The prize is not transferable or assignable.
30. Fulfillment of the prize will be handled by the KLC.

**ADDITIONAL CONDITIONS:**

31. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are subject to rules and regulations of the KLC and the laws of the Commonwealth of Kentucky.

32. By entering this promotion and accepting the prize, the player acknowledges and agrees that the KLC may use and release the player's name, city/state, and likeness (photograph) to the public, without limitation and without compensation.
33. By entering this promotion and accepting the prize, each entrant, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the promotion, any action taken pursuant to these rules, or the acceptance of any prize.
34. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for particular purpose.
35. Age restrictions may apply to redeem vouchers for certain products, merchandise or services.
36. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this promotion including the drawing at any time and for any reason including the award of any prize with the approval of the President & CEO or appropriate designee from the Executive Management group.
37. The KLC reserves the right to substitute prizes of equivalent value.
38. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business Monday – Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
39. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or appropriate designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
40. This promotion is void where prohibited by law.
