

Cash Pop “BONUS HOURS” August Test Pilot Promotion

Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a “BONUS HOURS” Terminal Promotion with Cash Pop at qualifying retailer and restaurant locations statewide. For participating qualifying locations, see the KLC website at kylottery.com.
2. The “BONUS HOURS” Promotion will run statewide on the following Thursdays, September 14th, 21st, & 28th 2023 and October 5th, 2023, from 5:00 – 8:00 pm E.T. (the Promotional Period), subject to the Promotional payout limit in Item 5.
3. Cash Pop tickets of ten dollars (\$10.00) or more in a single transaction purchased during the Promotional Period that receive “BONUS HOURS” printed on the ticket will increase any prize amount won by 50%. For example, a player who purchases five (5) POPs for \$2.00 per POP on a single ticket (\$10.00 wager) during the Promotional Period and wins a \$50.00 prize on that ticket may be eligible to increase their total prize amount by 50% bringing the total prize amount to \$75.00.
4. Cash Pop tickets may not be canceled.
5. The “BONUS HOURS” promotion is only available during the promotional period and will occur until the total promotional payout limit as set by the KLC is reached.
6. Promotion is valid at all qualifying KLC retailers and restaurant locations.
7. Tickets purchased via the internet using the KLC’s website or iLottery tickets are not eligible for this promotion.

ADDITIONAL CONDITIONS:

The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this promotion, including the promotional payout limit, at any time and for any reason, including the award of any prize, with the approval of the KLC’s President & CEO or her designee from the Executive Management group.
9. The promotion is subject to Kentucky law, the rules and regulations of the KLC, and the rules and regulations for Cash Pop.
10. You must be at least 18 years old to play.
11. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC’s President & CEO or her designee from the KLC’s Executive Management Group, after consultation with the KLC’s Internal Audit, Security and Legal Departments (if necessary), will be final.
