

Fun Club Registration Promotion

October, November, December 2025

Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Promotion for new Fun Club Members who are eligible to purchase KLC games via the Internet and who pass the KLC's age and identity verification requirements, and have a valid US address.
2. The Promotion will run from **12:00 AM ET Wednesday, October 1, 2025**, through **11:59 PM ET Friday, October 31, 2025**, (the "October Promotional Period"), from **12:00 AM ET Saturday, November 1, 2025**, through **11:59 PM ET Sunday, November 30, 2025** (the "November Promotional Period"), and from **12:00 AM ET Monday, December 1, 2025**, through **11:59 PM ET Wednesday, December 31, 2025** (the "December Promotional Period"), (collectively, the "Promotional Periods"), unless otherwise notified. The KLC reserves the right to change the dates of the Promotion. The drawing will be held on or about Monday, January 12, 2026.
3. The Promotion offer is as follows:
 - o Players who complete each of the following four (4) actions during a Promotional Period will receive one (1) entry into the drawing for that Promotional Period.
 - i. Successfully register and join Fun Club;
 - Players must pass age and identity verification and have a valid US address to be eligible for the Promotion.
 - ii. Deposit \$25 or more in a single transaction into the Fun Club Account;
 - iii. Play at least one (1) Instant Play Game; and
 - iv. Play at least one (1) Draw Game Online
4. Three (3) drawings will be conducted on or about Monday, January 12, 2026, one (1) for the October Promotional Period, one (1) for the November Promotional Period, and one (1) for the December Promotional Period. At the drawing, one (1) winner and five (5) alternates will be selected for each Promotional Period.
5. The prizes for this Promotion will be the following:
 - o October Promotional Period: One (1) winner will receive \$5,000 cash
 - o November Promotional Period: One (1) winner will receive \$5,000 cash
 - o December Promotional Period: One (1) winner will receive \$5,000 cash
6. A total of \$15,000 cash will be awarded during this Promotion.
7. The Promotion offer is only available during the Promotional Periods.

ELIGIBILITY:

8. To be eligible for the promotion, players must first successfully register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Terms of Use, including requirements for registering for or updating an existing account in order to enter

a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.

9. To play Kentucky Lottery retail and online games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club and Online Terms of Use.
10. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.

ODDS:

11. Odds of being selected as a winner in the Promotion will depend on the number of eligible entries received during the Promotional Period.

SUBMITTING ENTRIES:

12. Players who successfully register and join the Fun Club and complete all required actions outlined in Section 3 during a Promotional Period will automatically receive one (1) entry into the drawing for that Promotion Period.
13. A player is only eligible to receive one (1) entry into this Promotion for each Promotional Period the player completes all required actions.
14. By registering and joining Fun Club during a Promotional Period, the player agrees to these Rules and Regulations, the Rules and Regulations for the Online purchase of Instant Games, and the Fun Club Rewards Terms of Use and iLottery Terms of Use.

PRIZE DRAWING:

15. At the conclusion of the Promotional, KLC will run a report utilizing the criteria set forth in Section 3 for this Promotion.
16. A member of the Marketing team will upload the system-generated report into the Promotional Drawing System.
17. All drawing management services associated with this Promotion will be conducted by the KLC.
18. The drawings will be conducted per KLC drawing procedures.
19. During the drawings, alternates will be selected as noted in Section 4. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners, but are selected if a winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

PRIZE FULFILLMENT:

20. After the drawing(s) a member of the KLC's Marketing Department will send an email to the potential winner at the email address in the player's Fun Club profile at the time they entered the Promotion and provide a Promotion Claim Form the player must submit within the Claim Period to claim the prize. This email serves as the official notice of the win and the claim period set forth in Section 21 below will start once KLC sends the email. KLC is not required to make further attempts to contact the potential winner. It is the player's responsibility to check their email, including spam folder, for the official notice. KLC has no further obligation to notify a player in the event the official notice email bounces back, is quarantined by the player's email server, or is not otherwise received or viewed by the player within the Claim Period.
21. The prize for this Promotion must be claimed within the "Claim Period". The Claim Period begins once the official notice email is sent to the potential winner and ends at 5:00 PM ET on the third business day following the date the official notice is sent. If the potential winner fails to claim the prize as set forth below within the Claim Period, the player will be disqualified from winning the prize, and the prize will be awarded to the first eligible alternate selected.
22. The prize may only be claimed by the person whose name is on the winning entry. To claim the prize, the potential winner must provide a valid government issued photograph identification, such as a driver's license, or other form of photograph identification acceptable to the KLC, and an accurately completed Promotion Claim Form provided by the KLC Marketing Department. If all required information is not received by the KLC by the end of the Claim Period, the prize will be forfeited and awarded to the first qualifying alternate selected in the drawing. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted the prize will not be awarded.
23. All required information to claim the prize may be provided to the KLC by fax, email, U.S. Mail, or hand-delivery to the KLC Corporate Office. The KLC is not liable for any delay in receipt of information as a result of the potential winner's selected method of providing information to claim the prize. The KLC, in its discretion, may also provide a digital claim process with a verified electronic signature, such as DocuSign. If the player elects to send the information by fax or email, a member of the KLC's Marketing Department will provide a fax number or email address upon winner's request. If sent by U.S. Mail, winner can send all required information to: ATTENTION: DRAWING MANAGER, Kentucky Lottery Corporation, 1011 West Main Street, Louisville, KY 40202.

NOTE: When sending personally identifiable information, such as a Social Security Number, to the KLC by email, winners should use a secure or encrypted email. Information about how to use a secure or encrypted email may be requested from the Marketing Department.

24. If, prior to the expiration of the three (3) business days referenced in the preceding paragraph, a winner declines to accept and claim the prize by notifying a member of the KLC Marketing

Department in writing via the winner's e-mail, the prize may be forfeited immediately upon receipt of the written notification and the first eligible alternate declared the winner.

25. The KLC or its designee will withhold federal, state and all applicable taxes, according to federal and state withholding requirements. Any taxes above the standard formulas are the responsibility of the winner. Prizes may be subject to set-off of certain debts as required by law.
26. The prize is not transferable or assignable.
27. Fulfillment of the prize will be handled by the KLC.

ADDITIONAL CONDITIONS:

28. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
29. The Promotion is subject to Kentucky law and all applicable Rules and Regulations of the KLC.
30. By entering this Promotion, the player acknowledges and agrees that the KLC may use and release the player's name, city/state and likeness (photograph) to the public, without limitation and without compensation.
31. To play Internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Online Terms of Use.
32. This Promotion is only available at www.kylottery.com and the KLC app.
33. By funding their Fun Club account, players agree to these Rules and Regulations, the Fun Club Terms of Use and the Online Terms of Use.
34. By entering this Promotion, accepting the prize, or accepting any other prize, each entrant, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, and each of their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.
35. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for a particular purpose.
36. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion, including the drawing, at any time and for any reason, including the award of any prize, with the approval of the KLC's President & CEO or appropriate designee from the Executive Management group.

37. The KLC reserves the right to substitute prizes of equivalent value.
38. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business (holidays, weekends and other days the KLC is closed are excluded), and such day is from 8:00 AM to 5:00 PM ET.
39. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or appropriate designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
40. This Promotion is void where prohibited by law.
