**Kentucky Bourbon Trail® Second Chance Promotion**  
Statewide Omni Channel Promotion  
June 1 – 30, 2026  
Rules & Regulations

**GENERAL:**

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Second Chance Promotion called “Kentucky Bourbon Trail® Second Chance Promotion” (the “Promotion”) under the provisions of these Rules and Regulations. The Promotion is comprised of two (2) drawings:
  - **Fast Play Second Chance Drawing** (“Fast Play Second Chance Drawing”) for Kentucky Bourbon Trail® Fast Play tickets purchased at a Kentucky Lottery retailer; and
  - **Grand Prize Bonus Drawing** (“Grand Prize Bonus Drawing”) for Kentucky Bourbon Trail® Fast Play tickets purchased at a Kentucky Lottery retailer AND online purchase and play of the Kentucky Bourbon Trail® Instant Play game.
2. To enter the **Fast Play Second Chance Drawing**, a Player must enter one (1) eligible Kentucky Bourbon Trail® Fast Play ticket via the second chance promotion process.
3. Eligible tickets for the **Fast Play Second Chance Drawing** are defined as any single Kentucky Bourbon Trail® Fast Play ticket (Grid #66) that is purchased at any Kentucky Lottery Retailer AND entered into the drawing through the second chance promotion process during the specified Promotional Period.
4. To enter the **Grand Prize Bonus Drawing**, players must enter a Kentucky Bourbon Trail® Fast Play ticket into the **Fast Play Second Chance Drawing** as stated in Section 3 above, AND purchase and play the Kentucky Bourbon Trail® Instant Play game via the Kentucky Lottery website or app during the Promotional Period. Players who complete the two actions will automatically be entered into the Grand Prize Bonus Drawing.
5. The “Promotional Period” is between 12:00 AM ET on Monday, June 1, 2026, through 11:59 PM ET on Tuesday, June 30, 2026.
6. The **Fast Play Second Chance Drawing** and the **Grand Prize Bonus Drawing** will both be held on or about Thursday, July 9, 2026. The following prizes will be awarded.
  - **Fast Play Second Chance Drawing: \$250 Kentucky Bourbon Trail® Gift Certificate & \$250 Cash**
    - Three (3) winners will be selected with ten (10) alternates. The winners will each receive the following:
      - \$250 gift certificate to a participating Kentucky Bourbon Trail® member or partner location of the winner’s choice\* to use toward applicable on-property purchases (such as tour, lunch, tasting, gift shop, etc., as may be applicable). The winner will coordinate directly with the Kentucky Bourbon Trail® to choose and receive their Kentucky Bourbon Trail® Gift Certificate.
        - \* Kentucky Bourbon Trail® will provide a list of members and partner locations for winners to choose from.
      - \$250 cash provided by KLC
    - The total prize value amount given away for the Fast Play Second Chance Drawing will be \$1,500 (\$750 in Kentucky Bourbon Trail® gift certificate and \$750 cash).

- **Grand Prize Bonus Drawing: Grand Prize Package**
  - One (1) winner will be selected with ten (10) alternates to receive the following Prize Package valued at ~\$6,105.20. The winner will coordinate directly with the Kentucky Bourbon Trail® to schedule a two-day Bourbon Trip Experience (blackout dates may apply) for the winner and three (3) guests (all must be age 21 or over) as described below:
    - Private transportation provided by Sip Tours during the two-day Bourbon Trip excursion– Value ~\$3,055.20
    - Day 1 – Louisville Region
      - Stitzel-Weller Tour Experience and reserved table in Garden & Gun Club with a round of cocktails – Value ~\$200
      - A private behind-the-scenes distillery tour of Angel's Envy, followed by a guided tasting of some of our most exclusive whiskeys – Value ~\$500
      - WhistlePig Whiskey Hosted Tasting Experience – Value ~\$200
    - Hotel Accommodation - Two (2) Standard Rooms for a 1-night stay at The Seelbach Hilton Louisville – Valued ~ \$500
      - The following are not included and are the responsibility of the guest: transportation to and from the hotel, gratuities, parking, in-room purchases, and all other incidental expenses.
    - \$200 gift Card to Bourbons Bistro – Value \$200
    - Day 2 – Bardstown Region
      - The Bottled-in-Bond Tour and Tasting Experience at Heaven Hill Bourbon Experience, and lunch and one (1) complimentary cocktail at Five Brother Bar & Kitchen– Value ~\$250
      - Lux Row Distillers Behind-the-Scenes distillery tour and tasting of premium Lux Row Brands and artisan chocolates, and a handcrafted cocktail experience– Value ~\$300
      - Private Inside Scoop Tasting at Chicken Cock Whiskey Circa 1856 – Value ~\$150
    - \$750 Cash – provide by KLC for hotel accommodations after Day 2 – Bardstown Region tasting experience (winner responsible for booking their own accommodations), meals, souvenirs, etc. - Value \$750
    - *The winner and guests will begin and end their Bourbon Trip Experience in Louisville and are responsible for the costs of their own transportation to arrive and depart from Louisville.*

7. The total amount given away for the Promotion will be \$7,605.20
8. A Player can only win once in the **Fast Play Second Chance Drawing**. A Player who is drawn as a winner for the **Fast Play Second Chance Drawing** is eligible to win the **Grand Prize Bonus Drawing**.
9. To enter the Promotion, Players must first log-in or successfully register for a Fun Club account at [kylottery.com](http://kylottery.com). Players must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account, in order to submit tickets to enter a Promotion or to win a prize. Fun Club accounts that are not passing our age/identity verification, suspended, Opted Out or Manually Disabled are ineligible to enter or to win.

10. Once logged in, a Player will be able to submit eligible Kentucky Bourbon Trail® Fast Play tickets to enter the **Fast Play Second Chance Drawing**, see “Submitting Entries” Section below.
11. If a Player wishes to earn an entry into the Grand Prize Bonus Drawing, the Player must enter the Fast Play Second Chance Promotion as described above in Section 9 and 10 AND purchase and play the Kentucky Bourbon Trail® Instant Play Game Online (at any ticket price). A “Try” is not a qualifying play. Entries from Kentucky Bourbon Trail® Instant Play Game will be automatically accumulated and will not appear in the Submitted Entries page.
12. Entries must be received by 11:59:59 PM ET on the last date of the applicable Promotional Period to be entered into the drawing for this Promotion. Entries in this Promotions do not roll over to any other promotions or promotion periods.
13. Failure to fully provide required information will cause a Player’s request to register in the drawing to be rejected. Failure to provide accurate information could cause a Player whose entry is selected as a winner for the Promotion to be disqualified. A Player shall be considered ineligible if the KLC determines that a Player does not meet all Player eligibility requirements or provided false information.
14. The KLC assumes no responsibility for incorrect information provided by a Player on the registration form. After completing the registration, a Player is responsible for updating account information as needed by logging in and going to “My Account” on the profile page.
15. A Player may have no more than one (1) Fun Club account. A Player is not permitted to create additional Fun Club account in the event that his or her email or other relevant information changes. The Player may log in with his or her existing account credentials and make any desired changes at any time.

#### **ELIGIBILITY:**

16. A Player must be at least eighteen (18) years of age to participate. No one under eighteen (18) years of age and no one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.
17. The Grand Prize Package provided by the Kentucky Bourbon Trail™ requires the winner and guests to be at least 21 years of age or older to receive and participate in the Grand Prize Package Experiences. As stated in Section 46 below, the KLC is not responsible for any rules, regulations, restrictions or releases imposed or required by its promotional partners.
18. Players must have a valid U.S. address in order to register and participate. Accounts must pass the age, identity, and location verification to enter or to win. The KLC reserves the right to require additional verification details from a player to validate a winning entry.
19. Players may enter the **Fast Play Second Chance Drawing** up to 200 times per week during the Promotional Period by entering 200 eligible Fast Play tickets as part of Fun Club. One (1) entry in the **Fast Play Second Chance Drawing** = one (1) eligible Fast Play ticket. A week is defined as Sunday at 12:00:00 AM ET until the following Saturday at 11:59:59 PM ET. The KLC reserves the right to change, without notice, this limit on the number of tickets that may be entered weekly or daily. A player may only earn one (1) entry into the Grand Prize Bonus Drawing during the Promotional Period by entering

the Kentucky Bourbon Trail® Fast Play ticket AND purchasing and playing the Kentucky Bourbon Trail® Instant Play Game Online as stated in Section 11 above.

**ODDS:**

20. Odds of being selected as a winner in the Promotion will depend on the number of entries submitted for each drawing.

**SUBMITTING ENTRIES:**

21. Players can submit eligible Fast Play tickets for this Promotion at the KLC's website, [kylottery.com](http://kylottery.com), or through the Official Kentucky Lottery App. Any ticket physically sent to or dropped off at KLC's headquarters or any retailer, will be ineligible. The KLC will destroy all non-winning physical tickets received and the tickets will not be returned.
22. To submit an entry using the KLC's website, a Player must first log onto [kylottery.com](http://kylottery.com) using his or her unique account information. Once logged in, a Player submits an entry according to the instructions on the "Enter Tickets" page of the website. Required entry information from Fast Play tickets includes the 25-digit draw game code on the Fast Play ticket.
23. To submit a ticket using the KY Lottery App, a Player must have a functioning camera on his or her mobile device. The Player must select "Second Chance" from the side navigation menu on the App, and then must log onto the Player's Fun Club account using his or her unique account information. A Player must then select "Enter Tickets" from the menu. To submit the ticket, a Player must use his or her mobile device camera to line up the barcode on the Fast Play ticket within the viewfinder. A graphic with instructions can be found on the "Enter Tickets" tab of the App. The Player will receive a message if the ticket has been successfully scanned and entered into the Promotion. The Player will receive an error message if the ticket could not be scanned or was ineligible for entry.
24. An eligible Fast Play ticket may be submitted one (1) time only. The entry system will reject an entry if the 25-digit draw game code has been previously submitted.
25. To prevent fraudulent entries, after five (5) consecutive attempts to submit a ticket that is not recognized as an eligible ticket, a Player will be unable to submit entries for twelve (12) hours.
26. A complete entry for the Fast Play Second Chance Drawing is defined as successfully uploading an eligible Kentucky Bourbon Trail® Fast Play Game ticket into the second chance promotion process.
27. After an entry is accepted, the Player does not need to retain his or her ticket for the Promotion.
28. A complete entry for the Grand Prize Bonus Drawing is defined as successfully entering the Fast Play Second Chance Promotion as stated above in Section 25 and purchasing and playing the Kentucky Bourbon Trail® Instant Play game online within the Promotional Period.
29. By entering this Promotion, the Players agree to these rules and regulations, iLottery Terms of Use, the Fun Club Rewards Terms of Use, and the rules and regulations for the Kentucky Bourbon Trail® Fast Play game, and Kentucky Bourbon Trail® Instant Play game.

**DRAWINGS:**

30. All drawing management services associated with this Promotion will be conducted by the KLC.
31. The drawings will be conducted according to KLC drawing procedures.
32. Alternate will be selected at each drawing. Ten (10) alternates will be selected for the Fast Play Second Chance Drawing and ten (10) alternates for the Grand Prize Bonus Drawing as noted in Section 6. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners but are selected in the event that the winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a preliminary prize winner, his or her alternate status in the drawing will be voided.

**PRIZE FULFILLMENT:**

33. After the drawing(s) a member of the KLC's Marketing Department will send an email to the preliminary winner at the email address in the Player's Fun Club profile at the time they entered the Promotion and provide a Promotion Claim Form the Player must submit within the Claim Period to claim the prize. This email serves as the official notice of the win and the claim period set forth in Section 33 below will start once KLC sends the email. KLC is not required to make further attempts to contact the potential winner. It is the Player's responsibility to check their email, including spam folder, for the official notice. KLC has no further obligation to notify a Player in the event the official notice email bounces back, is quarantined by the Player's email server, or is not otherwise received or viewed by the Player within the Claim Period.
34. The prize for this Promotion must be claimed within the "Claim Period". The Claim Period begins once the official notice email is sent to the potential winner and ends at 5:00 PM ET on the third business day following the date the official notice is sent. If the potential winner fails to claim the prize as set forth below within the Claim Period, the Player will be disqualified from winning the prize, and the prize will be awarded to the first eligible alternate selected.
35. The prize may only be claimed by the person whose name is on the winning entry. To claim the prize, the potential winner must provide a valid government issued photograph identification, such as a driver's license, or other form of photograph identification acceptable to the KLC, and an accurately completed Promotion Claim Form provided by the KLC Marketing Department. If all required information is not received by the KLC by the end of the Claim Period, the prize will be forfeited and awarded to the first qualifying alternate selected in the drawing. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted, the prize will not be awarded.
36. All required information to claim the prize may be provided to the KLC by fax, email, U.S. Mail, or hand-delivery to the KLC Corporate Office. The KLC is not liable for any delay in receipt of information as a result of the potential winner's selected method of providing information to claim the prize. The KLC, in its discretion, may also provide a digital claim process with a verified electronic signature, such as DocuSign. If the Player elects to send the information by fax or email, a member of the KLC's Marketing Department will provide a fax number or email address upon winner's request. If sent by U.S. Mail, winner can send all required information to: ATTENTION: DRAWING MANAGER, Kentucky Lottery Corporation, 1011 West Main Street, Louisville, KY 40202.

*NOTE: When sending personally identifiable information, such as a Social Security Number, to the KLC by email, winners should use a secure or encrypted email. Information about how to use a secure or encrypted email may be requested from the Marketing Department.*

37. If, prior to the expiration of the three (3) business days referenced in Section 33, a winner declines to accept and claim the prize by notifying a member of the KLC Marketing Department in writing via the winner's e-mail, the prize may be forfeited immediately upon receipt of the written notification and the first eligible alternate declared the winner.
38. The KLC or its designee will withhold federal, state and all applicable taxes, according to federal and state withholding requirements. Any taxes above the standard formulas are the responsibility of the winner. Prizes may be subject to set-off of certain debts as required by law.
39. The prize is not transferable or assignable.
40. Fulfillment of the cash prize will be handled by the KLC. Fulfillment of the \$250 gift certificate and Grand Prize Package will be handled by the Kentucky Bourbon Trail®.

**ADDITIONAL CONDITIONS:**

41. The KLC is not responsible for the electronic misdelivery, late delivery, or failure to receive ticket information entered electronically, and the risk of loss remains with the Player regardless of the cause of the transmission failure.
42. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are subject to rules and regulations of the KLC and the laws of the Commonwealth of Kentucky.
43. By submitting an entry into the Promotion and claiming the prize, the Player certifies they are the sole owner of the entry, the Player is at least eighteen (18) years old, the ticket has been legally purchased, possessed and entered into the Promotion, and the Player is not disqualified from receiving a prize.
44. By entering this Promotion, the Player acknowledges and agrees that the KLC may use and release the Player's name, city/state and likeness (photograph) to the public, without limitation and without compensation.
45. By entering this Promotion, accepting the prize, participating in the Bourbon Trip Experience (including traveling to and from Louisville before, after, and during the Bourbon Trip Experience) or accepting any other prize, each Player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, and each of their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.
46. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for a particular purpose.
47. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion or the entire Promotion, including the drawing, at any time and for

any reason, including the award of any prize, with the approval of the KLC's President & CEO or appropriate designee from the Executive Management group.

48. The KLC reserves the right to substitute prizes of equivalent value.
49. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business (holidays, weekends and other days the KLC is closed are excluded), and such day is from 8:00 AM to 5:00 PM ET.
50. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or appropriate designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
51. This Promotion is void where prohibited by law.
