Stuff Your Wallet with Green and Gold Promotion
 Statewide Second Chance Promotion
 March 5 - April 15, 2026
 Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Second Chance Promotion called Stuff Your Wallet with Green & Gold Promotion with eligible Scratch-off tickets purchased at retail under the provisions provided in these Rules and Regulations.
2. To enter the Promotion, a player must enter an eligible Scratch-off ticket in the manner discussed below.
3. The “Promotional Period” is between 12:00 AM ET on Thursday, March 5, 2026, through 11:59 PM ET on Wednesday, April 15, 2026.
4. Eligible tickets are defined as any of the following Scratch-off tickets purchased at any Kentucky Lottery Retailer AND entered into the drawing during the specified Promotional Period.
 - \$2 Jefferson Scratch-off Ticket (Game No. 124)
 - \$5 Lincoln Scratch-off Ticket (Game No. 125)
 - \$10 Hamilton Scratch-off Ticket (Game No. 126)
 - \$20 Jackson Scratch-off Ticket (Game No. 127)
 - \$30 Deluxe Gold Scratch-off Ticket (Game No. 128)
5. Eligible tickets will receive an entry based upon the ticket value. The higher the ticket value, the more entries the player will receive for this Promotion. The chart below indicates the number of entries a player will receive based upon the single ticket value.

6. The drawings, one drawing for each Tier described below, will be held on or about Thursday, April 23, 2026. The following prizes will be awarded.
 - **Tier 1: \$10,000 cash winner**

- One (1) winner will be selected with five (5) alternates. The winner will receive \$10,000 cash.
 - The total amount given away for the drawing in Tier 1 will be \$10,000.
 - **Tier 2: \$5,000 cash winners**
 - Two (2) winners will be selected with ten (5) alternates. The winners will each receive \$5,000 cash.
 - The total amount given away for the drawing in Tier 2 will be \$10,000.
 - **Tier 3: \$1,000 cash winners**
 - Five (5) winners will be selected with ten (10) alternates. The winners will each receive \$1,000 cash.
 - The total amount given away for the drawing in Tier 3 will be \$5,000.
7. The total amount given away for the Promotion will be \$25,000.
8. A player can only win once in the Promotion.

ELIGIBILITY:

9. A player must be at least eighteen (18) years of age to participate. No one under 18 years of age and no one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.
10. Players must have a valid U.S. address in order to register and participate in this Promotion. Fun Club accounts must pass the age and identity verification to enter and to win.
11. A player may have no more than one (1) Fun Club account. A player is not permitted to create additional Fun Club accounts in the event that his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.
12. Players may enter up to 200 eligible Scratch-off tickets per week into the promotion as part of Fun Club. A week is defined as Sunday at 12:00:00 AM ET until the following Saturday at 11:59:59 PM ET. The KLC reserves the right to change, without notice, this limit on the amount of tickets that may be entered weekly or daily.
13. Games purchased via the internet using the KLC's website or app are not eligible for this Promotion.

ODDS:

14. Odds of being selected as a winner in the Promotion will depend on the number of entries submitted for each drawing.

SUBMITTING ENTRIES:

15. Players can submit eligible tickets for this Promotion at the KLC's website, kylottery.com, or through The Official Kentucky Lottery App. Any ticket physically sent to or dropped off at any

location whatsoever, will be ineligible. The KLC will destroy all non-winning physical tickets received at any lottery office and the tickets will not be returned.

16. To enter the Promotion, players must first log-in or register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Reward Terms of Use, including requirements for registering for or updating an existing account, in order to submit tickets to enter a Promotion or to win a prize. Fun Club accounts that are not passing our age/identity verification, Opted Out or Manually Disabled are ineligible to enter or to win.
17. Once logged in, a player will be able to submit eligible tickets to enter this Promotion.
18. To submit a ticket using the KLC's website, a player must first log onto kylottery.com using his or her unique account information. Once logged in, a player submits an entry according to the instructions on the "Enter Tickets" page of the website. Required information from the Scratch-off ticket includes the 18-digit VERN (void if removed number), which is located underneath the latex on the front of each Scratch-off ticket.
19. To submit a ticket using the KY Lottery App, a player must have a functioning camera on his or her mobile device. The player must select "Second Chance" from the side navigation menu on the App, and then must log onto the player's Fun Club account using his or her unique account information. A player must then select "Enter Tickets" from the menu. To submit the ticket, a player must use his or her mobile device camera to line up the barcode on the ticket within the viewfinder. A graphic with instructions can be found on the "Enter Tickets" tab of the App. The player will receive a message if the ticket has been successfully scanned and entered into the Promotion. The player will receive an error message if the ticket could not be scanned or was ineligible for entry.
20. An eligible ticket may be submitted one (1) time only. The entry system will reject a ticket that has been previously submitted.
21. To prevent fraudulent entries, after five (5) consecutive attempts to submit tickets that are not recognized as eligible tickets, a player will be unable to submit tickets for twelve (12) hours.
22. After a ticket is accepted, the player does not need to retain his or her ticket for the Promotion.
23. Tickets must be received by 11:59:59 PM ET on the last date of the applicable Promotional Period to be entered into the drawing for this Promotion.
24. Failure to fully provide required information will cause a player's request to register in the drawing to be rejected. Failure to provide accurate information could cause a player whose entry is selected as a winner for the Promotion to be disqualified. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements or provided false information.

25. The KLC assumes no responsibility for incorrect information provided by a player on their Fun Club Account. After completing the registration, a player is responsible for updating account information as needed by logging in and going to "My Account" on the profile page.
26. By entering this Promotion, the players agree to these rules and regulations, the rules and regulations for the subject scratch-off games, the iLottery Terms of Use, and the Fun Club Rewards Terms of Use.

DRAWINGS:

27. All drawing management services associated with this Promotion will be conducted by the KLC.
28. The drawings will be conducted according to KLC drawing procedures.
29. At each drawing, alternates will be selected for each Tier as noted in Section 6. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners but are selected in the event that the winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

PRIZE FULFILLMENT:

30. After the drawing(s) a member of the KLC's Marketing Department will send an email to the potential winner at the email address in the player's Fun Club profile at the time they entered the Promotion and provide a Promotion Claim Form the player must submit within the Claim Period to claim the prize. This email serves as the official notice of the win and the claim period set forth in Section 31 below will start once KLC sends the email. KLC is not required to make further attempts to contact the potential winner. It is the player's responsibility to check their email, including spam folder, for the official notice. KLC has no further obligation to notify a player in the event the official notice email bounces back, is quarantined by the player's email server, or is not otherwise received or viewed by the player within the Claim Period.
31. The prize for this Promotion must be claimed within the "Claim Period". The Claim Period begins once the official notice email is sent to the potential winner and ends at 5:00 PM ET on the third business day following the date the official notice is sent. If the potential winner fails to claim the prize as set forth below within the Claim Period, the player will be disqualified from winning the prize, and the prize will be awarded to the first eligible alternate selected.
32. The prize may only be claimed by the person whose name is on the winning entry. To claim the prize, the potential winner must provide a valid government issued photograph identification, such as a driver's license, or other form of photograph identification acceptable to the KLC, and an accurately completed Promotion Claim Form provided by the KLC Marketing Department. If all required information is not received by the KLC by the end of the Claim Period, the prize will be forfeited and awarded to the first qualifying alternate selected in the drawing. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted, the prize will not be awarded.

33. All required information to claim the prize may be provided to the KLC by fax, email, U.S. Mail, or hand-delivery to the KLC Corporate Office. The KLC is not liable for any delay in receipt of information as a result of the potential winner's selected method of providing information to claim the prize. The KLC, in its discretion, may also provide a digital claim process with a verified electronic signature, such as DocuSign. If the player elects to send the information by fax or email, a member of the KLC's Marketing Department will provide a fax number or email address upon winner's request. If sent by U.S. Mail, winner can send all required information to: ATTENTION: DRAWING MANAGER, Kentucky Lottery Corporation, 1011 West Main Street, Louisville, KY 40202.

NOTE: When sending personally identifiable information, such as a Social Security Number, to the KLC by email, winners should use a secure or encrypted email. Information about how to use a secure or encrypted email may be requested from the Marketing Department.

34. If, prior to the expiration of the three (3) business days referenced above, a winner declines to accept and claim the prize by notifying a member of the KLC Marketing Department in writing via the winner's e-mail, the prize may be forfeited immediately upon receipt of the written notification and the first eligible alternate declared the winner.
35. The KLC or its designee will withhold federal, state and all applicable taxes, according to federal and state withholding requirements. Any taxes above the standard formulas are the responsibility of the winner. Prizes may be subject to set-off of certain debts as required by law.
36. The prize is not transferable or assignable.
37. Fulfillment of the prize will be handled by the KLC.

ADDITIONAL CONDITIONS:

38. The KLC is not responsible for the electronic misdelivery, late delivery, or failure to receive ticket information entered electronically, and the risk of loss remains with the player regardless of the cause of the transmission failure.
39. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are subject to rules and regulations of the KLC and the laws of the Commonwealth of Kentucky.
40. By submitting an entry into the Promotion and claiming the prize, the player certifies they are the sole owner of the entry, the player is at least 18 years old, the ticket has been legally purchased, possessed and entered into the Promotion, and the player is not disqualified from receiving a prize.
41. By entering this Promotion, the player acknowledges and agrees that the KLC may use and release the player's name, city/state and likeness (photograph) to the public, without limitation and without compensation.

42. By entering this Promotion, accepting the prize, or accepting any other prize, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, and each of their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.
43. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for a particular purpose.
44. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion, including the drawing, at any time and for any reason, including the award of any prize, with the approval of the KLC's President & CEO or appropriate designee from the Executive Management group.
45. The KLC reserves the right to substitute prizes of equivalent value.
46. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business (holidays, weekends and other days the KLC is closed are excluded), and such day is from 8:00 AM to 5:00 PM ET.
47. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or appropriate designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
48. This Promotion is void where prohibited by law.
