Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct an Online Promotion for Millionaire for Life online purchases pursuant to these Rules and Regulations.
2. The Promotional Period will take place on Wednesday, February 25, 2026, from 12:00:00 AM ET until Saturday, February 28, 2026, at 11:59:59 PM ET (the "Promotional Period"). There will be a total of four (4) Promotional Days in the Promotional Period.
3. The Promotional offer is as follows:
 - Players who spend \$10 or more in a single transaction on Millionaire for Life Online draw game during a Promotional Day receive a \$2 Bonus only valid on Instant Play game purchases.
 - Players are eligible to receive the \$2 Instant Play Bonus once per Promotional Day. The \$2 Instant Play Bonus will expire thirty (30) days after the promotional award appears in the player's account.
 - All matters and claims relating to Millionaire for Life and Instant Play are governed by Kentucky law and the official rules and regulations for Millionaire for Life and Instant Play games.
4. The \$2 Instant Play Bonus will appear in the player's Fun Club account up to two (2) business days after the player has completed the purchase transaction.
5. The Bonus is applied directly to a player's Fun Club account and must be spent on Instant Play game purchases via the KLC's website or the KLC app; the Bonus cannot be withdrawn for a cash equivalent or redeemed for a retail purchase.
6. The \$2 Instant Play Bonus will expire thirty (30) days after the promotional award appears in the player's account.
7. The Promotion offer is only available during the Promotional Period.

ADDITIONAL CONDITIONS:

8. To be eligible for the Promotion, players must first register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
9. The Promotion is subject to Kentucky law, the rules and regulations of the KLC, and the rules and regulations for the Millionaire for Life and Instant Play Online games.
10. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.

11. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or receive a Bonus.
12. By entering this Promotion and accepting the \$2 Instant Play Bonus, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.
13. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion for any reason including the award of any prize with the approval of the President & CEO or appropriate designee from the Executive Management group.
14. The KLC reserves the right to substitute prizes of equivalent value.
15. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term “business day” means a day that the KLC Corporate Office is actually open for business Monday – Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
16. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or appropriate designee from the KLC’s Executive Management Group, will be final.
17. This Promotion is void where prohibited by law.
