“Best of Both” Mega Million Jackpot Reset
Statewide Terminal Promotions
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Statewide “Best of Both” Mega Millions Jackpot Reset Terminal Promotion at participating Kentucky Lottery retail locations.
2. The “Best of Both” Mega Million Jackpot Reset Terminal Promotion will begin when the Mega Million jackpot is reset to fifty million dollars (\$50,000,000)* and continue until the Mega Million jackpot reaches three hundred million dollars (\$300,000,000)**, (the “Promotional Period”), subject to the Promotional payout limit or unless earlier terminated pursuant to Section 6.

*The Promotion will begin at 10:00 am ET on the next business day after the KLC publishes, on the KLC’s website, that the Mega Millions jackpot has reset to fifty million dollars (\$50,000,000).

** The Promotion will terminate at 8:00 am ET on the next business day after the KLC publishes, on the KLC’s website, that the Mega Millions jackpot has reached or exceeded three hundred million dollars (\$300,000,000).

3. The Promotional offer is as follows:
 - Buy \$10 or more in **Mega Million** in a single ticket at a participating retailer during the Promotional Period, get a \$2 **Powerball Quick Pick*** Free
 - * The free Powerball Quick Pick ticket will be for the next draw.
4. The Promotion is valid only at participating retailers during the Promotional Period, or until the total Promotional payout limit as set by the KLC is reached.
5. Tickets purchased via the internet using the KLC’s website or the KLC app are not eligible for this Promotion.

ADDITIONAL CONDITIONS:

6. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any or all portions of this Promotion, including the promotional payout limit, at any time and for any reason, including the award of any prize, with the approval of the KLC’s President & CEO or her designee from the Executive Management group.
7. The Promotion is subject to Kentucky law, the rules and regulations of the KLC, and the rules and regulations for POWERBALL and MEGA MILLIONS.
8. Any and all taxes associated with any prize winnings associated with this Promotion are the responsibility of the winner. Prizes may be subject to set off of certain debts as required by law.
9. You must be at least 18 years old to play.
10. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC’s President & CEO or her designee from the KLC’s Executive Management Group, will be final.
