Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct an Online Promotion pursuant to these Rules and Regulations.
2. The Promotional Period will take place on the following five (5) Wednesdays in the month of July 2026 from 12:00:00 AM ET until 11:59:59 PM ET ("Promotional Days"), each with a different Promotional Offer as referenced below:
 - **Promotional Days:**
 - Wednesday, July 1, 2026
 - Players who Spend \$5 or more in a single transaction on Keno online during the Promotional Day will receive a \$1 Fun Club Bonus only valid on Instant Play plays.
 - Wednesday, July 8, 2026
 - Players who Spend \$5 or more in a single transaction on Pick 3 online during the Promotional Day will receive a \$1 Fun Club Bonus only valid on Instant Play plays.
 - Wednesday, July 15, 2026
 - Players who Spend \$5 or more in a single transaction on Pick 4 online during the Promotional Day will receive a \$1 Fun Club Bonus only valid on Instant Play plays.
 - Wednesday, July 22, 2026
 - Players who Spend \$10 or more in a single transaction on Millionaire for Life® online during the Promotional Day will receive a \$1 Fun Club Bonus only valid on Instant Play plays.
 - Wednesday, July 29, 2026
 - Players who Spend \$7 or more in a single transaction on Cash Pop online during the Promotional Day will receive a \$1 Fun Club Bonus only valid on Instant Play plays.
3. Players are eligible to receive one (1) \$1 Fun Club Bonus for each Promotional Day by completing the qualifying purchase and plays. A player can receive up to five (5) \$1 Fun Club Bonuses valid on Instant Play Online plays during the Promotional Period (one (1) Bonus per Promotional Day). The Bonus will expire thirty (30) days after the promotional award appears in the Player's account.
 - All matters and claims relating to the Promotion are governed by Kentucky law and the official Rules and Regulations for the draw games Keno, Pick 3, Pick 4, Millionaire for Life®, and Cash Pop, and Instant Play games.
4. The Bonus will appear in the Player's Fun Club account up to three (3) business days after the Player has completed the qualifying play transaction(s).
5. The Bonus is applied directly to a Player's Fun Club account and must be spent on Instant Play games purchased via the KLC's website or app; the Bonus cannot be withdrawn for a cash equivalent or redeemed for a retail purchase.

6. The Bonus will expire thirty (30) days after the promotional award appears in the Player's account.
7. The Promotion offer is only available during the Promotional Period.

ADDITIONAL CONDITIONS:

8. The Promotion is subject to Kentucky law, the Rules and Regulations of the KLC, Fun Club Rewards Terms of Use, iLottery Terms of Use, and the Rules and Regulations for the draw games Keno, Pick 3, Pick 4, Millionaire for Life®, and Cash Pop, and Instant Play games.
9. The KLC reserves the right to not award or revoke Bonuses and not award prizes to any player who the KLC reasonably suspects has engaged or attempted to engage in activity in violation of federal or Kentucky law, the Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, or any other applicable rules with respect to their registration or engagement on a KLC platform.
10. To be eligible for the Promotion, players must first successfully register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are suspended, Opted Out or Manually Disabled are ineligible to enter or to win.
11. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
12. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.
13. By entering this Promotion and accepting the Bonus, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.
14. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC further reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion or the entire Promotion prior to the end of the Promotional Period, for any reason including the award of any prize with the approval of the KLC's President & CEO or appropriate designee from the Executive Management group.
15. The KLC reserves the right to substitute Bonuses of equivalent value.
16. This Promotion is only available at www.kylottery.com and on the KLC mobile app.
17. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business Monday – Friday

(holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.

18. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or appropriate designee from the KLC's Executive Management Group, will be final.
19. This Promotion is void where prohibited by law.
