

KENTUCKY LOTTERY CORPORATION
Match 100% of First-Ever Deposit
Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Promotion for Fun Club Members who are eligible to purchase KLC games via the Internet pursuant to these Rules and Regulations.
2. The Promotion will run from **12:00 AM ET on Saturday, August 1, 2026, through 11:59 PM ET on Monday, August 31, 2026** (the "Promotional Period"), unless otherwise notified. The KLC reserves the right to change the dates of or cancel the Promotion, at any time and without notice.
3. The Promotion offer is as follows:
 - Players who make a first-ever deposit into their Fun Club account during the Promotional Period will receive a one hundred percent (100%) match in Fun Club Bonuses, up to maximum total first deposit Fun Club Bonus match of \$250 in Fun Club Bonuses. The 100% deposit match is only applicable to the first deposit transaction. Once the Player has made a first-ever deposit, the Player is no longer eligible to receive a match on subsequent deposits. For example:
 - i. If a Player makes their first-ever deposit of \$200 during the Promotional Period, the Player will receive a match of \$200 in Fun Club Bonuses.
 - ii. If a Player makes their first-ever deposit of \$500 during the Promotional Period, the Player will receive a maximum match of \$250 in Fun Club Bonuses.
 - Players can fund their Fun Club account via credit/debit card, PayPal, bank account, or iFund at retail (the "funding transaction"). Winnings deposited into a Fun Club Account via mobile cashing are not considered a qualifying deposit for this Promotion.
4. Fun Club Bonuses will appear in the Player's Fun Club account after the Player has completed the funding transaction. Fun Club Bonuses may take longer to appear in Fun Club accounts with registration addresses outside of Kentucky.
5. Fun Club Bonuses are applied directly to a Player's Fun Club account and must be spent on KLC games purchased via the Internet; Fun Club Bonuses cannot be withdrawn or redeemed for a retail purchase.
6. The Fun Club Bonus will expire thirty (30) days after the promotional award appears in the Player's account. Failure to use the Fun Club Bonus before the expiration will void the award.
7. Deposited funds cannot be withdrawn or refunded and can only be used to purchase KLC games online or at KLC retailers.
8. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the "funding transaction"). Winnings deposited into a Fun Club Account via mobile cashing are not considered a qualifying deposit for this Promotion.
9. The Promotion offer is only available during the Promotional Period, subject to the KLC's rights set forth in Section 12 below.

ADDITIONAL CONDITIONS:

10. To be eligible for the Promotion, the Player must first successfully register for a Fun Club account at kylottery.com. The Player must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are suspended, Opted Out or Manually Disabled are ineligible to take part in this Promotion.
11. Player's funding transactions are subject to a Player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a Player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
12. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC further reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion or the entire Promotion prior to the end of the Promotional Period, at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
13. The KLC reserves the right to not award or revoke Fun Club Bonuses and not award prizes to any player who the KLC reasonably suspects has engaged or attempted to engage in activity in violation of federal or Kentucky law, the Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, or any other applicable rules with respect to their registration or engagement on a KLC platform.
14. The Promotion is subject to Kentucky law, the rules and regulations of the KLC, Fun Club Rewards Terms of Use, and the iLottery Terms of Use.
15. To play Internet-based lottery games, Players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
16. This Promotion is void where prohibited by law.
17. This deposit Promotion cannot be combined with any other deposit promotional offers. Players who participate in this Promotion will not be eligible for any other or additional first-time deposit Promotions.
18. This Promotion is only available at www.kylottery.com and on the KLC mobile app.
19. By funding their Fun Club account, Players agree to these rules and regulations, the Fun Club Rewards Terms of Use and the iLottery Terms of Use.
20. By entering this Promotion and accepting the prize, each Player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion,

any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.

21. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or the designee from the KLC's Executive Management Group, will be final.
