# KENTUCKY LOTTERY CORPORATION 2025 Kentucky Lottery Wrap Online Promotion

Statewide Online Promotion Rules & Regulations

### **GENERAL:**

- 1. The Kentucky Lottery Corporation (KLC) plans to conduct a 2025 Kentucky Lottery Wrap Online Promotion pursuant to the provisions provided in these Rules and Regulations.
- 2. The Promotional Period will take place on the following five (5) Wednesdays in the month of December 2025 ("Promotional Day") from 12:00:00 AM ET until 11:59:59 PM ET, unless otherwise designated:
  - Promotional Days:
    - Wednesday, December 3, 2025
    - Wednesday, December 10, 2025
    - Wednesday, December 17, 2025
    - Wednesday, December 24, 2025
    - Wednesday, December 31, 2025
- 3. The drawing will be held on or about Thursday, January 8, 2025.
- 4. The Promotional offer is as follows:
  - Players who wager \$25 or more on the qualifying online game identified in a
    Promotional Day below (a "qualifying purchase"), will receive one (1) entry in the
    prize drawing associated with the Promotional Day(s) during which a qualifying
    purchase is made. A player who makes a qualifying purchase on all five (5)
    Promotional Days will also receive one (1) entry into the Tier 2 prize drawing for
    the Promotion. A "Try" is not a qualifying play.
    - December 3, 2025 Jackpot Spectacular
    - December 10, 2025 Fishing For Gold
    - December 17, 2025 Supernova 9s
    - December 24, 2025 Payout Pots
    - December 31, 2025 Elephant King JP
- 5. There are two (2) prize tiers for this Promotion and a total of six (6) prize drawings. There will be one (1) Tier 1 prize drawing for each Promotional Day for a total of five (5) Tier 1 prize drawings. There will be one (1) Tier 2 prize drawing for players that make a qualifying purchase each of the Promotional Days. The prize drawings are as follows:
  - Tier 1- Five (5) \$250 Cash Prize Drawings:
    - Ten (10) winners will be selected in each of the Promotional Day drawing to each win \$250 Cash, for a total of fifty (50) Tier 1 prize drawing winners.
    - A total of \$2,500 will be given away in Tier 1 drawings for each Promotional Day, for a total of \$12,500 in Tier 1 prizes.
  - Tier 2 One (1) \$2,025 Cash Prize Drawing:

- One (1) winner will be selected to win \$2,025 cash.
- A total of \$2,025 in cash will be awarded for the Tier 2 prize.
- 6. There will be fifteen (15) alternates selected in each Tier 1 drawing and three (3) alternates selected in the Tier 2 drawing.
- 7. Eligible players who satisfy the criteria described above in Section 4 will be automatically entered into the Promotion. The maximum number of entries per player for Tier 1 per Promotional Day is one (1) entry. The maximum number of entries per player for Tier 2 per Promotional Period is one (1) entry. A "TRY" is not a qualifying play.
- 8. This Promotion is only available at <u>play.kylottery.com</u> and the KLC app. Tickets purchased at retail are not eligible.
- 9. Player's funding transactions are subject to a player's Fun Club account balance and deposit limits.
- 10. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the "funding transaction").
- 11. All deposited funds must be spent on KLC games purchased via the Internet and cannot be withdrawn.

#### **ELIGIBILITY:**

- 12. A player who is selected as a winner for Tier 1 is eligible to be selected to win the Tier 2 Prize. However, a player may only win once for Tier 1 drawings. For example, a player cannot be selected twice for the Tier 1 drawing to receive more than one (1) \$250 cash prizes.
- 13. To be eligible for the Promotion, players must first successfully register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
- 14. Failure to provide accurate information could disqualify a player whose entry is selected as a winner for this Promotion. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements or provided false information.
- 15. The KLC assumes no responsibility for incorrect information provided by a player on the Fun Club registration form. After completing the registration, a player is responsible for updating account information as needed by logging in and going to his or her account profile page.

- 16. A player may have no more than one (1) Fun Club account. A player is not permitted to create additional accounts if his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.
- 17. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the iLottery Terms of Use.
- 18. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.

## ODDS:

19. Odds of being selected as a winner in each Promotional drawing will depend on the number of eligible entries that take place during the Promotional Period.

#### **SUBMITTING ENTRIES:**

- 20. After completing the qualifying purchase For Tier 1 as described in Section 4, players can receive one (1) entry per Promotional Day in the associate Tier 1 drawing. After completing the qualifying purchases for Tier 2 as described in Section 4, players can receive one (1) entry for the Tier 2 drawing.
- 21. By playing an Instant Play online game during the Promotional Period, the players agree to these Rules and Regulations, the Rules and Regulations for the online purchase of Instant Play games, and the Fun Club Rewards Terms of Use and iLottery Terms of Use.

## **PRIZE DRAWING:**

- 22. At the conclusion of the Promotional Period, KLC will run a Brightstar Lottery system-generated report utilizing the criteria set forth for this Promotion.
- 23. A member of the KLC Promotions Team will upload the system-generated report into the Promotional Drawing System.
- 24. All drawing management services associated with this Promotion will be conducted by the KLC.
- 25. The drawings will be conducted per KLC drawing procedures.
- 26. During the drawing, alternates will be selected as noted in Section 6. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners, but are selected if a winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate

is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

#### PRIZE FULFILLMENT:

- 27. A member of the KLC's Promotions Team will notify each winner using the email contact information provided in the winner's Fun Club profile at the time of the drawings.
  - The KLC may (but is not required to) also provide a courtesy call to the primary phone number provided on the winner's Fun Club profile. No further attempts to contact the winner by any method will be made. The email contact is the official notice of the win starting the claim period set forth in Section 28 below.
- 28. If the KLC determines that dialogue with a prize winner has not been established by phone, email, or other means acceptable to the KLC, within three (3) business days following the date of KLC's official email notice of the win, the winner will be disqualified, and the prize will be awarded to the first eligible alternate selected. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted; the prize will not be awarded.
- 29. All federal, state and/or local taxes or other fees on the prizes won will be the responsibility of the winner.
- 30. The prizes are not transferable or assignable.
- 31. Fulfillment of the prize will be handled by the KLC.

#### **ADDITIONAL CONDITIONS:**

- 32. The Promotion is subject to Kentucky law, the Rules and Regulations of the KLC, the Fun Club Rewards Terms or Use, iLottery Terms of Use, and the Rules and Regulations for Online games.
- 33. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are subject to Rules and Regulations of the KLC and the laws of the Commonwealth of Kentucky.
- 34. By entering this Promotion and accepting the prize, the player acknowledges and agrees that the KLC may use and release the player's name, city/state, and likeness (photograph) to the public, without limitation and without compensation.
- 35. By entering this Promotion and accepting the prize, each entrant, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating

to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.

- 36. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for particular purpose.
- 37. The KLC in its discretion reserves the right to change or extend any of the dates set out in these Rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion including the drawing at any time and for any reason including the award of any prize with the approval of the President & CEO or appropriate designee from the Executive Management group.
- 38. The KLC reserves the right to substitute prizes of equivalent value.
- 39. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business Monday Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
- 40. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or appropriate designee from the KLC's Executive Management Group, will be final.
- 41. This Promotion is void where prohibited by law.
