

**KENTUCKY LOTTERY CORPORATION**  
**Cyber Cash Bash Online Promotion**  
Statewide Online Promotion  
Rules & Regulations

**GENERAL:**

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Cyber Cash Bash Online Promotion for eligible Fun Club Members pursuant to these Rules and Regulations.
2. The Promotional Periods will take place on Monday, December 1, 2025, from 4:00pm ET to 7:00pm ET ("Promotional Day"), unless otherwise designated.
3. The Promotional offer is as follows:
  - Players who make one (1) or more deposits into their Fun Club Account, will receive a twenty-five percent (25%) match in Bonuses. A player can receive a maximum award of fifty dollars (\$50) in Bonuses on the Promotional Day. The Bonuses will expire thirty (30) days after the promotional award appears in the player's account.
4. The maximum Bonus match a player can receive is \$50. For example, if a player deposits \$200 in a single transaction, the player will receive the maximum award of \$50 in Bonuses. No additional Bonuses will be awarded if a player deposits more than \$200 during the Promotional Day.
5. A player may make multiple deposits during the Promotion Day to receive Bonuses up to the maximum match total of \$50 in Bonuses.
6. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the "funding transaction").
7. Bonuses will appear in the player's Fun Club account after the player has completed the funding transaction.
8. Bonuses are applied directly to a player's Fun Club account and must be spent on KLC games purchased via the KLC's website or the KLC app; Bonuses cannot be withdrawn for a cash equivalent or redeemed for a retail purchase.
9. The Bonuses will expire thirty (30) days after the promotional award appears in the player's account.
10. All deposited funds must be spent on KLC games purchased via the internet and cannot be withdrawn.
11. The Promotion offer is only available during the Promotional Period and to players eligible to play KLC games online.

**ADDITIONAL CONDITIONS:**

12. To be eligible for the Promotion, players must first register for a Fun Club account at [kylottery.com](http://kylottery.com). Players must be in compliance with all requirements of the Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
13. By funding their Fun Club account, players agree to these rules and regulations, the Fun Club Rewards Terms of Use and the iLottery Terms of Use.
14. A player's funding transactions are subject to a player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
15. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
16. The Promotion is subject to Kentucky law and rules and regulations of the KLC.
17. To play Internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
18. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any Bonus.
19. This Promotion is void where prohibited by law.
20. This deposit Promotion cannot be combined with any other deposit promotional offers.
21. This Promotion is only available at [www.kylottery.com](http://www.kylottery.com) and the KLC app.
22. The KLC reserves the right to substitute Bonuses or prizes of equivalent value.
23. By entering this Promotion and accepting the prize, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.
24. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or the designee from the KLC's Executive Management Group, Security and Legal Departments (if necessary), will be final.
