Golden Hour Online Promotion
Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Golden Hour Online Promotion for eligible Fun Club Members pursuant to these Rules and Regulations.
2. A Promotional Period will take place on each of the following five (5) Saturdays in the month of May from 5:00 PM ET until 7:00 PM ET (the “Promotional Period”), unless otherwise designated:
 - **Promotional Periods**
 - Saturday, May 2, 2026, from 5:00 PM ET until 7:00 PM ET
 - Saturday, May 9, 2026, from 5:00 PM ET until 7:00 PM ET
 - Saturday, May 16, 2026, from 5:00 PM ET until 7:00 PM ET
 - Saturday, May 23, 2026, from 5:00 PM ET until 7:00 PM ET
 - Saturday, May 30, 2026, from 5:00 PM ET until 7:00 PM ET
3. The Promotional offer is as follows:
 - During each Promotional Period, players who deposit into their Fun Club Account during the Promotional Period (“qualifying deposit”), will receive a 25% Fun Club Bonus Match, up to a \$50 Fun Club Bonus Match based on the total amount deposited during a Promotional Period.
 - A player can receive a maximum total of \$250 in Fun Club Bonuses during this Promotion (\$50 in Fun Club Bonuses each Promotional Period date). The Fun Club Bonuses will expire thirty (30) days after the promotional award appears in the player’s account.
4. The maximum Fun Club Bonuses a player can receive in a Promotional Period is a cumulative of \$50 in Fun Club Bonus Match. No additional Fun Club Bonuses will be awarded if a player makes a deposit or multiple deposits during a Promotional Period where 25% of cumulative deposits exceeded \$50.
5. To qualify for the 25% Fun Club Bonus Match, the player must deposit into their Fun Club account during the Promotional Period. A player who, for example, makes an initial deposit of \$50 and a subsequent \$50 deposit during a Promotional Period will receive a 25% Bonus Match for each amount deposited within the Promotional Period (\$50 deposit x 25% = \$12.50 Fun Club Bonus Match on each deposit). This process would continue to occur until a player hits the \$50 Fun Club Bonus Match max within the Promotional Period or the Promotion ends, whichever is first to occur.
6. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the “funding transaction”). Winnings deposited into a Fun Club Account via mobile cashing are not considered a qualifying deposit for this Promotion.
7. Fun Club Bonuses will appear in the player’s Fun Club account after the Player has completed the qualifying deposit.

8. Fun Club Bonuses are applied directly to a player's Fun Club account and must be spent on KLC games purchased via the KLC's website or KLC app; Fun Club Bonuses cannot be withdrawn for a cash equivalent or redeemed for a retail purchase.
9. The Fun Club Bonuses will expire thirty (30) days after the promotional award appears in the player's account.
10. Deposited funds cannot be withdrawn or refunded and can only be used to purchase KLC games online or at KLC retailers.
11. The Promotion offer is only available during the Promotional Period and to players eligible to play KLC games online.

ADDITIONAL CONDITIONS:

12. The Promotion is subject to Kentucky law, the Rules and Regulations of the KLC, Fun Club Rewards Terms of Use, iLottery Terms of Use, and the Rules and Regulations for Online games.
13. To be eligible for the Promotion, players must first successfully register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are suspended, Opted Out or Manually Disabled are ineligible to enter or to win.
14. By funding their Fun Club account, players agree to these Rules and Regulations, the Fun Club Rewards Terms of Use and the iLottery Terms of Use.
15. A player's funding transactions are subject to a player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
16. The KLC, in its sole discretion, reserves the right to modify, suspend, postpone or cancel, without notice, any of the dates set out in these rules. The KLC further reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion for any reason or the entire Promotion prior to the end of the Promotional Period, with the approval of the KLC's President & CEO or appropriate designee from the Executive Management group.
17. The KLC reserves the right to not award or revoke Fun Club Bonuses and not award prizes to any player who the KLC reasonably suspects has engaged or attempted to engage in activity in violation of federal or Kentucky law, the Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, or any other applicable rules with respect to their registration or engagement on a KLC platform.
18. To play Internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
19. This Promotion is void where prohibited by law.

20. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any Bonus or prize.
21. This deposit Promotion cannot be combined with any other deposit promotional offers.
22. This Promotion is only available at www.kylottery.com and the Kentucky Lottery app.
23. The KLC reserves the right to substitute Bonuses or prizes of equivalent value.
24. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term “business day” means a day that the KLC Corporate Office is actually open for business Monday – Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
25. By entering this Promotion and accepting the Bonus, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.
26. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC’s President & CEO or the designee from the KLC’s Executive Management Group, Security and Legal Departments (if necessary), will be final.
