NASCAR® Powerball – the Chase Promotion
Statewide Powerball® Retail Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Second Chance Promotion with eligible Powerball® tickets purchased at KLC retailers under the provisions provided in these Rules and Regulations. For Powerball® plays purchased via the internet using the KLC's website (Online tickets) see the Rules and Regulations for the Online NASCAR Powerball – The Chase Second Chance Promotion: <https://www.kylottery.com/apps/funclub/terms.html?pane=terms>
2. To enter this Promotion, a Player must enter an eligible ticket purchased at a KLC retailer during the Promotional Period.
3. The "Promotional Period" is between **12:00:00 AM ET on Monday, May 4, 2026, and 11:59:59 PM ET on Sunday, June 14, 2026**. The drawing will be held on or about Monday, June 22, 2026.
4. An Eligible Ticket is defined as a single Powerball® ticket with a total cost of \$10 or more purchased during the Promotional Period at a Kentucky Lottery retailer.
5. There will be one (1) drawing held for this Retail Promotion on or about Monday, June 22, 2026.
 - **Retail Second Chance Drawing: \$600 cash winners**
 - Five (5) winners will be selected with ten (10) alternates. The winners will each receive \$600 cash and will be entered into the NASCAR Powerball – The Chase Kentucky Grand Prize drawing.
 - A total of \$3,000 cash will be awarded during this Promotion.
6. There will be one (1) drawing held for the NASCAR Powerball – The Chase Kentucky Grand Prize winner, which will be held on or around Tuesday, June 30, 2026. The five (5) winners from the Retail Second Chance Drawing and the five (5) winners from the Online Second Chance Drawing will each receive one (1) entry into this drawing.
 - **NASCAR Powerball – The Chase Kentucky Grand Prize Winner Drawing**
 - One (1) winner will be selected with nine (9) alternates. The winner will advance to NASCAR Powerball – The Chase, and receive \$2,000.
7. The NASCAR Powerball – The Chase Kentucky Grand Prize Winner will advance to the NASCAR Powerball – The Chase for a chance to win up to \$1,010,000 and win a VIP Trip Experience Prize Package provided by MUSL, or a third-party under contract with MUSL to fulfill elements of the trip prize. Each participating state lottery will provide one (1) eligible Player to MUSL to be entered into the national pool for the Drawing 1 of The Chase (see below). Twenty (20) winners will be drawn by MUSL in Drawing 1 to each receive \$3,000 and advance to Drawing 2. The Chase will continue based on the elimination drawing schedules and prize payouts outlined in the table below:

8.  - All meals while in Florida
 - Ground transportation to and from airports, hotel, and activities in Florida.

9. The specific procedures and terms of the NASCAR Powerball – The Chase Grand Prize drawing will be determined by MUSL in its sole discretion.

10. The Promotion is only available during the Promotional Period.

ELIGIBILITY:

11. A player can only win once in the Retail Second Chance Promotion Drawing.

12. A player must be at least eighteen (18) years of age to participate. No one under 18 years of age and no one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.
13. Players must have a valid U.S. address in order to register and participate in this Promotion. Fun Club accounts must pass the age and identity verification to enter and to win.
14. A player may have no more than one (1) Fun Club account. A player is not permitted to create additional Fun Club accounts in the event that his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.
15. Players may enter up to 200 eligible Powerball® tickets per week into the promotion as part of Fun Club. A week is defined as Sunday at 12:00:00 AM ET until the following Saturday at 11:59:59 PM ET. The KLC reserves the right to change, without notice, this limit on the number of tickets that may be entered weekly or daily.
16. Games purchased via the internet using the KLC's website or app are not eligible for the Retail Second Chance Promotion.

ODD:

17. Odds of being selected as a winner in the Promotion will depend on the number of entries submitted for each drawing.

SUBMITTING ENTRIES:

18. Players can submit eligible tickets for this Promotion at the KLC's website, kylottery.com, or through The Official Kentucky Lottery App. Any ticket physically sent to or dropped off at any retailer or KLC's headquarters will be ineligible. The KLC will destroy all non-winning physical tickets received and the tickets will not be returned.
19. To enter the Promotion, players must first log-in or successfully register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Reward Terms of Use and iLottery Terms of Use, including requirements for registering for or updating an existing account, in order to submit tickets to enter a Promotion or to win a prize. Fun Club accounts that are not passing our age/identity/location verification, Opted Out or Manually Disabled are ineligible to enter or to win.
20. Once logged in, a player will be able to submit eligible tickets to enter this Promotion.
21. To submit a ticket using the KLC's website, a player must first log onto kylottery.com using his or her unique account information. Once logged in, a player submits an entry according to the instructions on the "Enter Tickets" page of the website. Required entry information from draw game ticket includes the 25 digit draw game code on the draw game ticket.
22. To submit a ticket using the KY Lottery App, a player must have a functioning camera on his or her mobile device. The player must select "Second Chance" from the side navigation menu on the App, and then must log onto the player's Fun Club account using his or her unique account information. A player

must then select “Enter Tickets” from the menu. To submit the ticket, a player must use his or her mobile device camera to line up the barcode on the ticket within the viewfinder. A graphic with instructions can be found on the “Enter Tickets” tab of the App. The player will receive a message if the ticket has been successfully scanned and entered into the Promotion. The player will receive an error message if the ticket could not be scanned or was ineligible for entry.

23. An eligible ticket may be submitted one (1) time only. The entry system will reject a ticket that has been previously submitted.
24. To prevent fraudulent entries, after five (5) consecutive attempts to submit tickets that are not recognized as eligible tickets, a player will be unable to submit tickets for twelve (12) hours.
25. After a ticket is accepted, the player does not need to retain his or her ticket for the Promotion.
26. Tickets must be received by 11:59:59 PM ET on the last date of the applicable Promotional Period to be entered into the drawing for this Promotion.
27. Failure to fully provide required information will cause a player’s request to register in the drawing to be rejected. Failure to provide accurate information could cause a player whose entry is selected as a winner for the Promotion to be disqualified. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements or provided false information.
28. The KLC assumes no responsibility for incorrect information provided by a player on their Fun Club Account. After completing the registration, a player is responsible for updating account information as needed by logging in and going to “My Account” on the profile page.
29. By entering this Promotion, the players agree to these rules and regulations, the rules and regulations for Powerball®, the iLottery Terms of Use, the Fun Club Rewards Terms of Use, the laws of the Commonwealth of Kentucky, rules and regulations of the KLC, and rules and regulations of MUSL.

KLC RETAIL SECOND CHANCE DRAWING AND NASCAR POWERBALL – THE CHASE KENTUCKY GRAND PRIZE WINNER DRAWINGS:

30. The KLC Retail Second Chance Drawing and NASCAR Powerball – The Chase Kentucky Grand Prize Winner Drawing management services associated with this Promotion will be conducted by the KLC.
31. The drawing will be conducted according to KLC drawing procedures.
32. At the drawing for the Retail Second Chance Promotion, ten (10) alternates will be selected. At the drawing for the NASCAR Powerball – The Chase Kentucky Grand Prize Winner drawing nine (9) alternates will be selected. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners but are selected in the event that the winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

KLC PRIZE FULFILLMENT OF RETAIL SECOND CHANCE DRAWING AND NASCAR POWERBALL – THE CHASE KENTUCKY GRAND PRIZE WINNER DRAWINGS:

33. After the Retail Second Chance Drawing and the NASCAR Powerball – The Chase Kentucky Grand Prize Winner drawings are held, a member of the KLC’s Marketing Department will send an email to the potential winners at the email address in the player’s Fun Club profile at the time they entered the Promotion and provide a Promotion Claim Form the player must submit within the Claim Period to claim the prize. This email serves as the official notice of the win and the claim period set forth in Section 34 below will start once KLC sends the email. KLC is not required to make further attempts to contact the potential winner. It is the player’s responsibility to check their email, including spam folder, for the official notice. KLC has no further obligation to notify a player in the event the official notice email bounces back, is quarantined by the player’s email server, or is not otherwise received or viewed by the player within the Claim Period.
34. The prize for the Retail Second Chance Drawing and the NASCAR Powerball – The Chase Kentucky Grand Prize Winner drawings Promotion must be claimed within the “Claim Period”. The Claim Period begins once the official notice email is sent to the potential winner and ends at 5:00 PM ET on the third business day following the date the official notice is sent. If the potential winner fails to claim the prize as set forth below within the Claim Period, the player will be disqualified from winning the prize, and the prize will be awarded to the first eligible alternate selected.
35. The prize may only be claimed by the person whose name is on the winning entry. To claim the prize, the potential winner must provide a valid government issued photograph identification, such as a driver’s license, or other form of photograph identification acceptable to the KLC, and an accurately completed Promotion Claim Form provided by the KLC Marketing Department. If all required information is not received by the KLC by the end of the Claim Period, the prize will be forfeited and awarded to the first qualifying alternate selected in the drawing. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted, the prize will not be awarded.
36. All required information to claim the prize may be provided to the KLC by fax, email, U.S. Mail, or hand-delivery to the KLC Corporate Office. The KLC is not liable for any delay in receipt of information as a result of the potential winner’s selected method of providing information to claim the prize. The KLC, in its discretion, may also provide a digital claim process with a verified electronic signature, such as DocuSign. If the player elects to send the information by fax or email, a member of the KLC’s Marketing Department will provide a fax number or email address upon winner’s request. If sent by U.S. Mail, winner can send all required information to: ATTENTION: DRAWING MANAGER, Kentucky Lottery Corporation, 1011 West Main Street, Louisville, KY 40202.

NOTE: When sending personally identifiable information, such as a Social Security Number, to the KLC by email, winners should use a secure or encrypted email. Information about how to use a secure or encrypted email may be requested from the Marketing Department.

37. If, prior to the expiration of the three (3) business days referenced above, a winner declines to accept and claim the prize by notifying a member of the KLC Marketing Department in writing via the winner’s e-mail, the prize may be forfeited immediately upon receipt of the written notification and the first eligible alternate declared the winner.

38. The KLC or its designee will withhold federal, state and all applicable taxes, according to federal and state withholding requirements. Any taxes above the standard formulas are the responsibility of the winner. Prizes may be subject to set-off of certain debts as required by law.

39. The prize is not transferable or assignable.

40. Fulfillment of these prizes will be handled by the KLC.

MUSL SEMI-FINALISTS & FINALIST DRAWINGS:

41. Each participating lottery will provide one (1) semi-finalist to participate in NASCAR Powerball - The Chase. Each semi-finalist will receive \$2,000 cash. Public announcement of all semi-finalists on Sunday, September 6, 2026, during the race at Darlington Speedway in Darlington, SC.

- Due to the public nature of the promotion, all national semi-finalist names will be made public. Semi-finalists will be required to sign name and image release forms from NASCAR® and NBC.

42. MUSL will conduct Drawing 1 on September 9, 2026, and will select twenty (20) semi-finalists from the semi-finalists pool to advance in NASCAR Powerball - The Chase. Public announcement of the twenty (20) semi-finalists will be on Sunday, September 27, 2026, during the race at Kansas Motor Speedway in Kansas City, KS. The advancing twenty (20) semi-finalists will win \$3,000 cash.

43. MUSL will conduct Drawing 2 on September 30, 2026, and will select ten (10) semi-finalists from the Drawing 1 winners to advance in NASCAR Powerball - The Chase. Public announcement of the ten (10) semi-finalists will be on Sunday, October 18, 2026, during the race at Phoenix Speedway in Phoenix, AZ. The advancing ten (10) semi-finalists will win \$5,000 cash.

44. MUSL will conduct Drawing 3 on October 7, 2026, and will select four (4) semi-finalists from the Drawing 2 winners to advance in NASCAR Powerball - The Chase. Public announcement of the four (4) semi-finalists will be on Sunday, November 1, 2026, during the race at Martinsville Speedway in Martinsville, VA. The advancing four (4) semi-finalists will win a VIP Trip as outlined in Section 7 valued at ~\$10,000.

45. MUSL will conduct Drawing 4 (the final drawing) live on November 8, 2026, from the NASCAR Cup Series Championship Race™ at Homestead-Miami Speedway® in Homestead, FL. One (1) winner will be selected to win \$1,000,000. The three (3) other semi-finalists will receive \$10,000.

THE CHASE VIP PRIZE EXPERIENCE TRIP PRIZE TERMS AND CONDITIONS

47. The KLC is not responsible for the electronic misdelivery, late delivery, or failure to receive ticket information entered electronically, and the risk of loss remains with the player regardless of the cause of the transmission failure.

48. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are subject to rules and regulations of the KLC, rules and regulations of MUSL, rules and regulations of NASCAR Powerball – The Chase, and the laws of the Commonwealth of Kentucky.
49. By submitting an entry into the Promotion and claiming the prize, the player certifies they are the sole owner of the entry, the player is at least 18 years old, the ticket has been legally purchased, possessed and entered into the Promotion, and the player is not disqualified from receiving a prize.

52. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners, including, but not limited to, MUSL and NASCAR®. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for a particular purpose.
53. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion or the entire Promotion prior to the end of the Promotional Period, including the drawing, at any time and for any reason, including the award of any prize, with the approval of the KLC's President & CEO or appropriate designee from the Executive Management group.
54. The KLC reserves the right to substitute prizes of equivalent value.
55. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business (holidays, weekends and other days the KLC is closed are excluded), and such day is from 8:00 AM to 5:00 PM ET.
56. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or appropriate designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
57. This Promotion is void where prohibited by law.
