National Lottery Day Online Promotion
Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a National Lottery Day Online Promotion pursuant to the provisions provided in these Rules and Regulations.
2. The Promotional Period will take place from **12:00AM ET until 11:59PM ET on Friday, July 17, 2026** ("Promotional Period"), unless otherwise designated.
3. The Promotional offer is as follows:
 - Players who wager a total of thirty dollars (\$30) or more on KLC products online during the Promotional Period will receive one (1) entry into the drawing. A Player can receive only one (1) entry during the Promotional Period.
4. The drawing will be held on or about Thursday, July 23, 2026.
5. During the drawing, seventeen (17) winners will be selected to each win \$100 in Fun Club Bonuses. A total of \$1,700 in Fun Club Bonuses will be given away in the drawing. The Bonus will expire thirty (30) days after the promotional award appears in the player's account.
6. There will be ten (10) alternates selected in the drawing.
7. Eligible Players who satisfy the criteria described above in Section 3 will be automatically entered into the Promotion. The maximum number of entries per Player is one (1) entry.
A "TRY" is not a qualifying play.
8. This Promotion is only available at play.kylottery.com and the KLC app. Tickets purchased at retail are not eligible.
9. Player's funding transactions are subject to a player's Fun Club account balance and deposit limits.
10. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the "funding transaction").
11. Deposited funds cannot be withdrawn or refunded and can only be used to purchase KLC games online or at KLC retailers.
12. Fun Club Bonuses cannot be withdrawn or used for retail purchases.

ELIGIBILITY:

13. A player can only win once in this Promotion.
14. To be eligible for the Promotion, players must first successfully register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
15. Failure to provide accurate information could disqualify a player whose entry is selected as a winner for this Promotion. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements, provided false information, or is suspected of violating the iLottery Terms of Use, Fun Club Terms of Use, or any other rules and regulations of the KLC.
16. The KLC assumes no responsibility for incorrect information provided by a player on the Fun Club registration form. After completing the registration, a player is responsible for updating account information as needed by logging in and going to his or her account profile page.
17. A player may have no more than one (1) Fun Club account. A player is not permitted to create additional accounts if his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.
18. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the iLottery Terms of Use.
19. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any prize.

ODDS:

20. Odds of being selected as a winner in the Promotional drawing will depend on the number of eligible entries that take place during the Promotional Period.

SUBMITTING ENTRIES:

21. After completing the qualifying purchase for the Promotion as described in Section 3, Players will automatically receive an entry for the drawing associated.

22. By playing online during the Promotional Period, the players agree to these Rules and Regulations, the Rules and Regulations for Online Games, the Fun Club Rewards Terms of Use, and iLottery Terms of Use.

PRIZE DRAWING:

23. At the conclusion of the Promotional Period, KLC will run a Brightstar Lottery system-generated report utilizing the criteria set forth for this Promotion.
24. A member of the KLC Promotions Team will upload the system-generated report into the Promotional Drawing System.
25. All drawing management services associated with this Promotion will be conducted by the KLC.
26. The drawings will be conducted per KLC drawing procedures.
27. During the drawing, alternates will be selected as noted in Section 6. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners, but are selected if a winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

PRIZE FULFILLMENT:

28. A member of the KLC's Promotions Team will notify each winner using the email contact information provided in the winner's Fun Club profile at the time of the drawings.
29. The prizes are not transferable or assignable.
30. Fulfillment of the prize will be handled by the KLC.

ADDITIONAL CONDITIONS:

31. The Promotion is subject to Kentucky law, the Rules and Regulations of the KLC, the Fun Club Rewards Terms or Use, iLottery Terms of Use, and the Rules and Regulations for Online games.
32. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. Validity of entries, drawings, and the award of prizes are

subject to Rules and Regulations of the KLC and the laws of the Commonwealth of Kentucky.

33. By entering this Promotion and accepting the prize, the player acknowledges and agrees that the KLC may use and release the player's name, city/state, and likeness (photograph) to the public, without limitation and without compensation.
34. The KLC reserves the right to not award or revoke Bonuses and not award prizes to any player who the KLC reasonably suspects has engaged or attempted to engage in activity in violation of federal or Kentucky law, the Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, or any other applicable rules with respect to their registration or engagement on a KLC platform.
35. By entering this Promotion and accepting the prize, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any prize.
36. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for particular purpose.
37. The KLC in its discretion reserves the right to change or extend any of the dates set out in these Rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion or the entire Promotion prior to the end of the Promotional Period, including the drawing at any time and for any reason including the award of any prize with the approval of the President & CEO or appropriate designee from the Executive Management group.
38. The KLC reserves the right to substitute prizes of equivalent value.
39. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business Monday – Friday (holidays, weekends and other days the KLC is closed are excluded), and such day is from 12:00:00 AM to 11:59:59 PM ET.
40. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or appropriate designee from the KLC's Executive Management Group, will be final.

41. This Promotion is void where prohibited by law.
