Refer A Friend Bonus Award Online Promotion
Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a promotion for Fun Club Members who are eligible to purchase KLC games via the Internet pursuant to these Rules and Regulations.
2. The Promotion will run from **12:00 AM ET on Tuesday, September 1, 2026, through 11:59 PM ET on Wednesday, September 30, 2026** (the "Promotional Period"), unless earlier terminated. The KLC reserves the right to change the dates of or cancel the Promotion, at any time and without notice.
3. The Promotion offer is as follows:
 - Fun Club Members who successfully invite a qualified friend(s) to join Fun Club and play online (the "Referring Fun Club Member") within the Promotional Period will receive a \$50 Fun Club Bonus for each qualifying referral ("Referred Friend").
 - The qualified Referred Friend, as defined below, will receive a \$20 Fun Club Bonus for completing all requirements outlined in this Section 3 below.
 - A Referring Fun Club Member can earn a Fun Club Bonus award for each successful Referred Friend who completes the registration and deposit requirements within the Promotional Period. The Referred Friend can only receive the Referred Friend Bonus award once.
 - In order for the Referring Fun Club Member and the qualified Referred Friend to each receive their respective Fun Club Bonus, each of the requirements must be met within the Promotional Period:
 - i. The Referred Friend has not previously registered for a Fun Club account; and
 - ii. The Referred Friend must successfully register for Fun Club with the same email address the Referring Fun Club Member provided (no Bonuses will be awarded if information provided by the Referred Friend varies from what was provided by the referring Fun Club member) and be eligible to play KLC games online; and
 - iii. The Referred Friend must enter the promo code received from the Referring Friend during the Referred Friend's registration process; and
 - iv. The Referred Friend must deposit at least \$10 into their Fun Club account after their successful Fun Club account registration.
4. The Referring Fun Club Member and Referred Friend will each receive a \$1 Fun Club Bonus after the Referred Friend completes all action items outlined in Section 3 above. The Referring Fun Club Member will receive a \$50 Fun Club Bonus, and the Referred Friend will receive a \$20 Fun Club Bonus in their respective Fun Club accounts within five (5) business days after the Referred Friend completes all action items outlined in Section 3 above.

5. Fun Club Bonuses are applied directly to a Player's Fun Club account and must be spent on KLC games purchased via the Internet; Fun Club Bonuses cannot be withdrawn or redeemed for a retail purchase.
6. The Fun Club Bonuses will expire thirty (30) days after the promotional award appears in the Player's account. Failure to use the Fun Club Bonus before the expiration will void the award.
7. Deposited funds cannot be withdrawn or refunded and can only be used to purchase KLC games online or at KLC retailers.
8. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the "funding transaction"). Winnings deposited into a Fun Club Account via mobile cashing are not considered a qualifying deposit for this Promotion.
9. The Promotion offer is only available during the Promotional Period, subject to the KLC's rights set forth in Section 13 below.
10. This Promotion cannot be combined with any affiliate offers or promo codes.

ADDITIONAL CONDITIONS:

11. To be eligible for the Promotion, the Player must first successfully register for a Fun Club account at kylottery.com. The Player must be in compliance with all requirements of the iLottery Terms of Use and Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are suspended, Opted Out or Manually Disabled are ineligible to take part in this Promotion.
12. Player's funding transactions are subject to a Player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a Player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
13. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC further reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion or the entire Promotion prior to the end of the Promotional Period, at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
14. The KLC reserves the right to not award or revoke Fun Club Bonuses and not award prizes to any player who the KLC reasonably suspects has engaged or attempted to engage in activity in violation of federal or Kentucky law, the Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, or any other applicable rules with respect to their registration or engagement on a KLC platform.
15. The Promotion is subject to Kentucky law, the rules and regulations of the KLC, Fun Club Rewards Terms of Use, and the iLottery Terms of Use.

16. To play Internet-based lottery games, Players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
17. This Promotion is void where prohibited by law.
18. Players who participate in this Promotion will not be eligible for any other or additional first-time deposit Promotions.
19. This Promotion is only available at www.kylottery.com and on the KLC mobile app.
20. By registering for a Fun Club account, Players agree to these rules and regulations, the Fun Club Rewards Terms of Use and the iLottery Terms of Use.
21. By entering this Promotion and accepting the Bonus prize, each Player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.
22. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or the designee from the KLC's Executive Management Group, will be final.
