

**KENTUCKY LOTTERY CORPORATION**  
**Registration Promotion**  
**Statewide Online Promotion**  
**Rules & Regulations**

**GENERAL:**

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Promotion for new Fun Club Members who are eligible to purchase KLC games via the Internet.
2. The Promotion will run from 12:00 AM ET on Thursday, January 1, 2026, through 11:59 PM ET on Saturday, February 28, 2026 (the “Promotional Period”), unless otherwise notified. The KLC reserves the right to change the dates of the Promotion without notice.
3. The Promotion offer is as follows:
  - Players who successfully register and join the Fun Club during the Promotional Period will receive a \$5 Bonus valid only on Instant Play Games. Players must pass age and identity verification and have a valid US address to be eligible for the Promotion.
4. The Bonus should appear in the eligible Player’s Fun Club account within twenty-four (24) hours of their successful registration.
5. The Bonus is applied directly to a Player’s Fun Club account and must be spent on KLC Instant Play Games purchased via the KLC website or KLC mobile app; Bonuses cannot be withdrawn or redeemed for a retail purchase.
6. The Bonus play will expire five (5) days after the promotional award appears in the Player’s account. Failure to use the Bonus before the expiration will void the award.
7. All deposited funds must be spent on KLC Instant Play Games purchased via the Internet and cannot be withdrawn.
8. The Promotion offer is only available during the Promotional Period.

**ADDITIONAL CONDITIONS:**

9. To be eligible for the Promotion, the Player must first successfully register for a Fun Club account at [kylottery.com](http://kylottery.com) or on the KLC mobile app. The Player must be in compliance with all requirements of the Fun Club Rewards Terms of Use, including requirements for registering for or updating an existing account in order to enter a

promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to take part in this Promotion.

10. Player's funding transactions are subject to a Player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a Player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
11. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
12. The Promotion is subject to Kentucky law, Fun Club Rewards Terms of Use, iLottery Terms of Use, the rules and regulations of the KLC, and the rules and regulations for Instant Play game.
13. To play Internet-based lottery games, Players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club Rewards Terms of Use and iLottery Terms of Use.
14. This Promotion is void where prohibited by law.
15. This Promotion is only available at [www.kylottery.com](http://www.kylottery.com) and on the KLC mobile app.
16. By registering for a Fun Club account, Players agree to these rules and regulations, the Fun Club Rewards Terms of Use and the iLottery Terms of Use.
17. By entering this Promotion and accepting a Bonus, each Player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.
18. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or the designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
