Statewide Online Promotion
Rules & Regulations

GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a Tiki Tuesdays Promotion for eligible Fun Club Members pursuant to these Rules and Regulations.
2. The Promotional Period will take place on the following four (4) Tuesdays in the month of August ("Promotional Day") from 12:00:00 AM ET until 11:59:59 PM ET., unless otherwise designated:
 - **Promotional Days**
 - Tuesday, August 5, 2025
 - Tuesday, August 12, 2025
 - Tuesday, August 19, 2025
 - Tuesday, August 26, 2025

3. The Promotional offer is as follows:

For each Promotional Day, players who deposit \$100 or more into their Fun Club Account, in a single transaction ("qualifying deposit"), will receive a \$30 Bonus. A player can receive a \$30 Bonus each Promotional Day for a maximum total of \$120 in Bonuses during this Promotion (\$30 Bonus per each Promotional Day). The Bonuses will expire thirty (30) days after the promotional award appears in the player's account.

4. The maximum bonus a player can receive in a Promotion Day is \$30. No additional bonuses will be awarded if a player makes multiple deposits of \$100 or more in a single transaction during a Promotional Day.
5. To qualify for the \$30 Bonus, the player must deposit \$100 or more in a single transaction. A player who, for example, makes an initial deposit of \$50 and a subsequent \$50 deposit during a Promotional Day will not receive a \$30 Bonus because a deposit of \$100 or more was not made in a single transaction.
6. Players can fund their Fun Club account via credit/debit card, Apple Pay, PayPal, bank account, or iFund at retail (the "funding transaction").
7. Bonuses will appear in the player's Fun Club account after the player has completed the funding transaction.
8. Bonuses are applied directly to a player's Fun Club account and must be spent on KLC games purchased via the KLC's website or KLC app; Bonuses cannot be withdrawn for a cash equivalent or redeemed for a retail purchase.
9. The Bonuses will expire thirty (30) days after the promotional award appears in the player's account.

10. All deposited funds must be spent on KLC games purchased via the internet and cannot be withdrawn.
11. The Promotion offer is only available during the Promotional Period and to players eligible to play KLC games online.

ADDITIONAL CONDITIONS:

12. By funding their Fun Club account, players agree to these Rules and Regulations, the Terms of Use for Fun Club and the iLottery Terms of Use.
13. A player's funding transactions are subject to a player's Fun Club account balance and deposit limits. If the addition of the funding amount would cause a player's account balance or deposit limits to be exceeded, the funding amount cannot be added to the account.
14. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this Promotion at any time, and for any reason, with the approval of the KLC's President and CEO or the designee from the Executive Management group.
15. The Promotion is subject to Kentucky law and Rules and Regulations of the KLC.
16. To play Internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the Fun Club and iLottery Terms of Use.
17. This Promotion is void where prohibited by law.
18. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this Promotion or win any Bonus or prize.
19. This deposit promotion cannot be combined with any other deposit promotional offers.
20. This Promotion is only available at www.kylottery.com and the Kentucky Lottery app.
21. The KLC reserves the right to substitute Bonuses or prizes of equivalent value.
22. By entering this Promotion and accepting the prize, each player, his or her heirs, legal representatives and assigns, agree to indemnify and hold harmless, defend, release and discharge the KLC, the Commonwealth of Kentucky, their employees, officers and directors from and against any loss, claim, damages, or injury arising out of or relating to the Promotion, any action taken pursuant to these rules, or the acceptance of any promotional offering or prize.
23. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President & CEO or the designee from the KLC's Executive Management Group, Security and Legal Departments (if necessary), will be final.
