MILLIONAIRE FOR LIFE OFFICIAL GAME RULES

ADDENDUM

Section 1 Governing Rules

All matters and claims relating to this “Millionaire for Life” Game, including but not limited to purchases, transactions, determination of prize winners, validation, and prize claims, are governed by this Addendum, Kentucky law, the individual Millionaire for Life Official Game Rules, and the General Draw Games Rules and Regulations, which are incorporated herein by reference. The purchase of “Millionaire for Life” through the Kentucky Lottery Corporation’s website at kylottery.com (“iLottery”) and official KLC app is governed by the Fun Club Rewards Terms of Use, Rules for the iLottery Purchase of Draw Games, and the iLottery Terms of Use, which are incorporated herein by reference, in addition to these Rules. These Rules collectively contain the sole and exclusive remedy for any and all claims.

Section 2 Retailer Selling Bonus

The retailer selling bonus for the sale of a Grand Prize winning ticket (Match 5 + 1 prize, which will be an annuity prize of \$1,000,000 a year for life or the cash value of \$18,000,000 in a one-time lump sum cash payment) shall be Ten Thousand Dollars (\$10,000). The retailer selling bonus for the sale of a Second Level Prize winning ticket (Match 5 + 0 prize, will be an annuity prize of \$100,000 a year for life or the cash value of \$2,200,000 in a one-time lump sum cash payment) shall be One Thousand Dollars (\$1,000) . In the event there are multiple prize winning tickets for a single prize, each retailer selling bonus will be reduced in proportion to the number of winners.

Section 3 Proof of Life Requirement for Grand Prize and Second Level Prize Winners Electing Annuity Option

(a) Once each year, within forty-five (45) days to thirty (30) days prior to the anniversary of the winning ticket validation date (“proof of life period”), each Grand Prize and Second Level Prize winner who elect the annuity prize payout option shall provide to the KLC an affidavit, on a form to be provided by the KLC, signed by the Winner, bearing the seal of a notary public, verifying that the Winner is living, containing the Winner’s current address, and specifying the method of payment of the payments (check or wire transfer) and providing a bank account number and all information necessary to complete the wire transfer, if the annuity option is chosen (the “Affidavit”). The Affidavit must be sent, by certified mail, to the KLC and must be received by the KLC during the proof of life period. In computing the period of time specified in these rules, the last day of the period so computed is to be included unless it is a Saturday, Sunday, or legal holiday, in which event the period runs until the end of the next day which is not a Saturday, Sunday, or legal holiday.

(b) If a Winner does not provide the Affidavit specified in the preceding Section 3 (a), then the KLC may not make further prize payments until such time as it receives a completed Affidavit or the notice and other information specified in Section (a) above. No interest shall be

paid by the KLC on the value of the prize during any period that a prize payment was not made due to failure of the Winner to provide the Affidavit.

(c) The KLC shall be notified of the Winner's death as soon as reasonably possible, but no later than sixty (60) days following the date of death, and such notice shall include a certified copy of the Winner's death certificate.

Section 4 Interpretation of Millionaire for Life Official Game Rules

The President of the Kentucky Lottery Corporation shall have the authority to interpret and apply, and if necessary, amend or modify the Millionaire for Life Official Game Rules in order to comply with the laws of the Commonwealth of Kentucky and to implement sales of the Millionaire for Life Game.

Section 5 Internet Ticket Sales

All purchases on the KLC website are governed by the KLC's Rules for the iLottery Purchase of Draw Games, the iLottery Terms of Use, and the Millionaire for Life Official Game Rules. A Millionaire for Life iLottery Draw Game Ticket means an electronic or virtual ticket or play, and is purchased only through the KLC's website or the official KLC mobile app. The purchase of an iLottery Draw Game Ticket is a "ticketless transaction" under the Millionaire for Life Official Game Rules.
