**ADDENDUM FOR MULTIPLIER FREQUENCY**

The purpose of this Addendum is to set out the rules governing the ability of the Kentucky Lottery Corporation (“KLC”) to improve the frequency of the 2X, 3X, 4X, 5X, and/or 10X Multiplier odds, in its discretion, for promotional purposes or to provide added value to players, so as provide increased opportunities for the 10X, 5X, 4X, 3X, and/or 2X to be drawn and to increase the overall payout for Keno with Multiplier. The KLC will have the discretion to change the frequency and odds of the Multiplier features in the following manner.

1. The KLC may, at the discretion of the President, amend the odds for the Keno Multiplier feature to increase the frequency and improve the odds of the 2X, 3X, 4X, 5X, and/or 10X using an amended prize structure (hereinafter the “Amended Multiplier Prize Structure.”)
2. The Amended Multiplier Prize Structure will be available during a promotional or other defined period or periods to be determined and announced by the KLC.
3. Prior to the time any Amended Multiplier Prize Structure is implemented, the KLC will publish prominently on its website, as an Addendum to the Keno Game Rules, the specific Multiplier Prize Structure with the amended odds for each Multiplier.

The following Amended Multiplier Prize Structure will be implemented during the promotional period from March 11, 2024, to April 12, 2024.

<b>Multiplier</b>	<b>Odds</b>
10X	1:26.66
5X	1:26.66
4X	1:16
3X	1:16
2X	1:2.35
1X	1:2.66

4. Except as otherwise modified by this Addendum during the period(s) an Amended Multiplier Prize Structure is implemented, all other terms, conditions, rules, and regulations set forth in the Kentucky Lottery Corporation Rules and Regulation for Keno with Multiplier apply.
5. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of the Amended Multiplier Prize Structure, including the amended Multiplier frequency and payout, at any time and for any reason, including the award of any prize, with the approval of the KLC’s President & CEO or his designee from the Executive Management group.

6. The Amended Multiplier Prize Structure is subject to Kentucky law, the rules and regulations of the KLC, and the rules and regulations for Keno with Multiplier.
7. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the KLC's President & CEO or her designee from the KLC's Executive Management Group, after consultation with the KLC's Internal Audit, Security and Legal Departments (if necessary), will be final.
